Dear Mayor Wilson,

The County Library currently has three open Library Board positions on its nine-member board.

During the past few months, the Library Board Development Committee, including Board Chair Bill Scarber, Vice-Chair Hollie Pettersson, Board Member Nancy Thorne and I have conducted a valley-wide recruitment and interviewed prospective candidates.

In reviewing candidate qualifications we considered the following:

- Skills and experience that support library priorities.
- The current composition of the board.
- Representation of diverse communities.
- Distribution of representation throughout the county.
- Understanding of library principles of intellectual freedom and personal privacy and the role of the library in the community now and into the future.

The Library Board is currently composed of one individual from Council District 1, one from Council District 2, one from Council District 3, one from Council District 4, one from District 6 and an At-Large County Council Representative. Five board members identify as female, one identifies a male. We currently have representation from the Hispanic and Pacific Island communities and a diverse ranges of ages. Their experience is in education, early literacy, social work, human behavior, and banking. The current board members skills and experience support the library's priorities of early learning, education, community engagement, literacy and fiscal stewardship.

After carefully reviewing applications, resumes and supplemental questions, and having had the opportunity to conduct personal interviews of each candidate, the Board Development Committee is proud to unanimously recommend that the following individuals be appointed to the Library Board and forwarded to the County Council for advice and consent.

- Anastasia Morgan, currently residing in District 6. Anastasia is a 2018 law school graduate. Her current practice includes Family Law, Parental Rights, Estate Planning and representing survivors of Domestic Violence. Anastasia has been recognized as a Top 10 Under 40 Family Law Attorney and served as a Track Coach for the Special Olympics. She brings an important young voice to the Library Board with experience in legislative matters, public policy, procedural issues and a spirit of collaboration.

- Steven S. Sokol, currently residing in District 5. Steven is a CPA and Internal Auditor who will bring experience in internal auditing, financial reporting processes and advocacy to the Library Board. Steven was the past President of the Salt Lake Chapter of the Institute of Internal Auditors and was recognized as the Speaker of the Year by the Association of Healthcare Internal Auditors for his presentation “Audit Evidence, Auditing in the Age of Instagram”.
- Spencer Romney, currently residing in District 4. Spencer is a Spanish speaker who earned his Juris Doctor, graduating Magna Cum Laude from the University of Pennsylvania Law School in 2010. He is a former Adjunct Professor at the University of Utah, S.J. Quinney College of Law, earned a Certificate in Business and Public Policy from Warton School of Business and a B.S. in Accounting from Brigham Young University.

The all three candidates spoke to the power that the public library has to affect positive changes in individuals and communities, to the importance of representing residents within our entire service area and their commitment to ensure equitable service for all. The Board Development Committee enthusiastically recommends these extremely qualified candidates and thrilled they have chosen to volunteer their time and service to Salt Lake County.
