The Children's Justice Center has received some one-time funding from the State of Utah to assist with renovations of their existing location in West Jordan as well as a new location in Salt Lake City. The State of Utah fiscal year is from July-June so the expending of these funds will span across fiscal 2024 and 2025 for Salt Lake County. The amount of the original one-time funding is \$175,000.00 and the 2024 portion of this funding (\$116,630) was submitted under Form ID33983 in November of last year.
