## Please tell us about yourself.

Salt Lake City has been my home since 1985 when I moved here to attend my residency in Family Medicine at the University of Utah Health Sciences. ## Why are you interested in serving on a board or commission?

After the pandemic I became deeply concerned about the misinformation and lack of support for public health. I hope by sitting on this board I will better understand the function of the SL County Health Department and help promote evidence-based standards.

# What education, work experience, or volunteer experience do you have that applies to the board you are applying for?

1) Pursuing my MD and residency in Family Medicine helped with a basic understanding of medical care including a focus on evidence-based care. 2) Working at the Homeless Clinic and Community Health Centers broadened my understanding of the social determinant of health to improve patient outcomes. 3) While on faculty at the U I developed research skills especially around systems management and administrative functions as medical director of the Madsen Clinic. 4) Developing a private practice afforded me business skills to function in the for profit world 5) All these opportunities gave me skills which will help me understand and work with SL County Health Board.

Working on plans to help develop a local Blue Zone designation. Blue zones are
