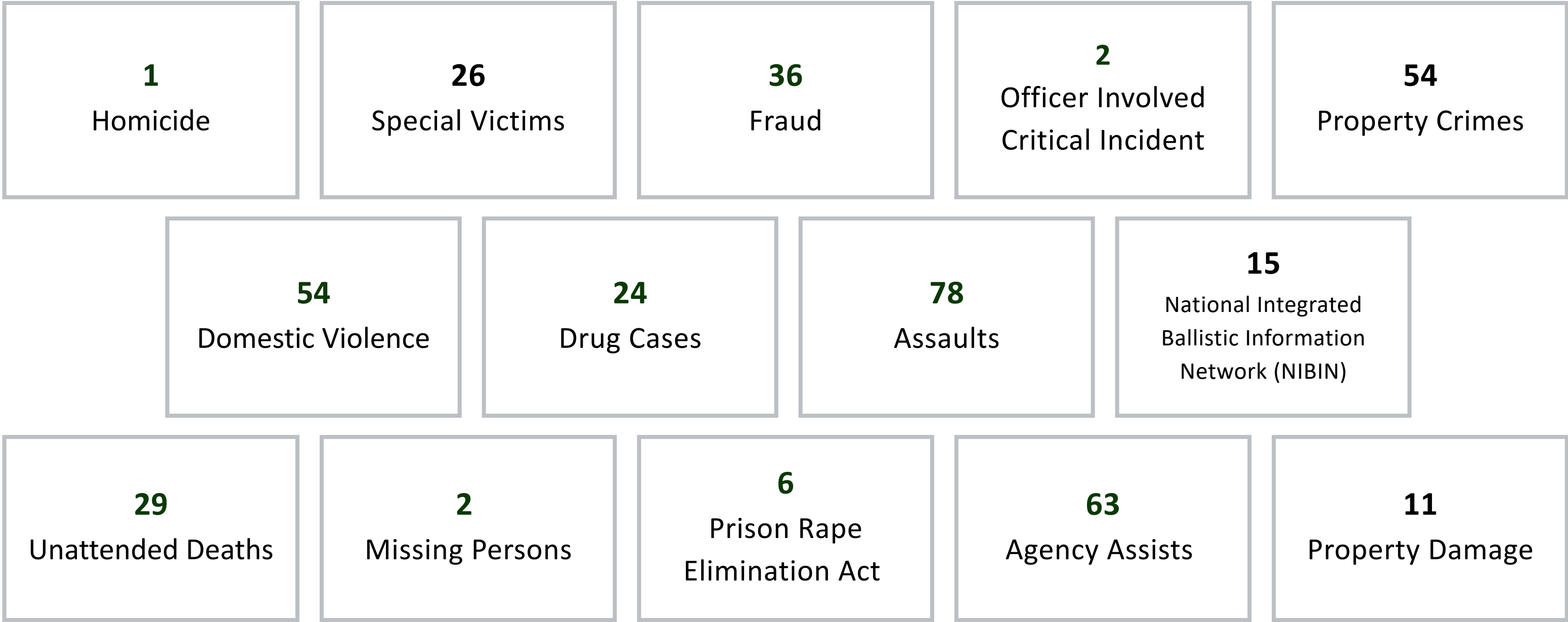

SIU - INVESTIGATION DETAILS

Homicide

- Mt. Olympus Trailhead | ~3,000 hours, 51 warrants | Title III wiretap added 1,080 hours | 5 gang members arrested

Unattended Deaths

- 21 in the canyons | 4 in the islands | 4 in the jail

Agency Assists

- 57 among all agencies within the county | 1 Wyoming - assisted identifying vehicle in nationwide ATM theft ring | 1 Juab County - consulted on death investigation | 1 Moab - linked to multi state ATM theft (TX, OK, CO, NE); ATM found in Nephi | 1 Davis County - SVU case involving CSAM | 2 San Juan County - homicide cases

Assault Investigations

- 1 aggravated assault on peace officer | 3 aggravated assaults by prisoners | 74 assaults by prisoners

Special Victims

- 14 felony cases | 30 search warrants | 5 arrests | 2 out of state assists

Domestic Violence

- 42 investigations | misdemeanor to felony level cases

Fraud

- 33 felony cases, 1 federal | ~400 hours, 40 subpoenas/warrants | \$45,500 recovered

Victim Advocate

- 17 cases supported | 2 callouts | created new training

SIU - TASK FORCE INVOLVEMENT

Detectives serve on specialized task forces to enhance investigative capabilities, strengthen interagency collaboration, access critical intelligence, and use federal resources.

- **Child Abduction Response Team (CART):** rapid, multi-agency response to child abduction cases - Utah AG's Office
- **Human Trafficking Task Force:** investigates trafficking cases and supports victims through coordinated response - Utah AG's Office
- **Internet Crimes Against Children (ICAC):** targets online child exploitation - Utah AG's Office
- **ATF Task Force:** supports gun violence investigations and ballistic analysis through the National Integrated Ballistic Information Network (NIBIN) - Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF)
- **Fentanyl Death Investigation Task Force:** investigate overdose deaths linked to fentanyl distribution - Drug Enforcement Agency (DEA)
- **FBI Cyber Crimes Task Force** (*in process*): focuses on cyber-enabled fraud and digital threats
- **FBI Violent Crimes Task Force** (*in process*): tackles violent crime through federal partnerships and intelligence sharing
- **Secret Service Financial Crimes Task Force:** collaborates on investigations into fraud and financial crimes (works with task force but not formally assigned)

SIU - TASK FORCE DETAILS

Child Abduction Response Team (CART)

Two call outs to support time-sensitive investigations

Human Trafficking

In 2024, the task force opened 4,782 Child Sexual Abuse Material (CSAM) cases—a 498% increase since 2018

Internet Crimes Against Children (ICAC)

Assisted other agencies with four cases to date, resulting in federal and state charges

Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF)

13 cases resulting in federal indictments; SIU has assisted five agencies to date, with additional requests anticipated due to specialized resources

Fentanyl Death Investigation

Consulted/assisted four agencies on overdose investigations

FBI Cyber Crimes Task Force

In partnership with Homeland Security Investigations (HSI), tracked a suspect to Canada in a multi-million-dollar ski pass fraud involving stolen credit cards used to purchase lift tickets (IKON Case)
