Re: Clark Planetarium Advisory Board Appointments

Over the last several years, the advisory board, in partnership with Clark Planetarium and Community Services leadership, has aimed to increase diversity and gender representation on the board, as well as increase geographic representation to include members from all six council districts. The board also seeks members with strong community connections and members that bring industry expertise from fields that include the aerospace, technology, science and education fields.

The Clark Planetarium (CP) is seeking to fill four (4) vacant seats on the Clark Planetarium Advisory Board. The planetarium accepted applications from across the county. Promising candidates were granted interviews with CP staff and board leadership. Subsequently, the interview panel discussed each board member and their alignment with our strategic plan and general planetarium needs. Candidates were ranked in order of preference. The planetarium currently needs representation from District 6.

We are recommending the following to fill those vacancies and have listed the reason(s) why:

1) Jonathan Ebbeler is the Principal Partner for eFUSION consulting.

He has extensive experience working in the Public Sector and would be advantageous to have on the board for strategic planning. He has a BS in Economics, Purdue University with an additional year of PhD coursework/research under a NSF-funded grant researching cost modeling of public infrastructure. He also has a fellow of Academy of Excellence in Local Governance from the University of Maryland School of Public Policy.

Jonathan resides in District 4.

2) Madelaine Miller Anderson is a former 4th grade teacher in the Canyons School District.

Granddaughter of Larry H. and Gail Miller, she serves on one of the committees for the Miller family charitable giving and would provide continuity to the Gail and Larry H. Miller Foundation, which has been generous to CP in the past. As a teacher and mother, she brings an important perspective to the way we conduct the engaging elements of our mission.

Madelaine resides in District 6.

3) Marisol Perez Gonzalez, is the Network Director for the United Way of Salt Lake.

She has an MPA with a concentration in Education and Nonprofit Organizations and a BS in Ethnic Studies and Sociology from the University of Utah. She was the Program Coordinator for First Star Academy for the University of Utah, focusing on the Office of Undergraduate Studies, Equity, Diversity, and Inclusion. She would enhance the diversity of the board and be instrumental in helping Clark Planetarium reach underserved communities.

Marisol resides in District 6.



4) **Rodney Parker is an attorney at the Snow, Christensen & Martineau law firm.**

His practice focuses on civil and criminal appeals, family law and general litigation. His firm has been supportive of the planetarium in the past. He is also an accomplished amateur astronomer with his own telescope and has assisted his son with Star Parties at the Natural History Museum of Utah.

Rodney resides in District 6.
