4. Discussion Items

4.1 Proposed Changes to the 2020 June Budget

20-0505

Mr. Darrin Casper, Salt Lake County Deputy Mayor of Finance & Administration, stated the primary sources of revenue for the TRCC Fund are from restaurant, transient room, and car rental taxes. Those funds have been decimated by the Covid pandemic. The County's Revenue Committee estimates these funds will be down 40 percent this year, based on a partial recovery. Therefore, the County delayed every project that it could.

Cultural and Convention

Ms. Holly Yocom, Director, Salt Lake County Community Services Department, delivered a PowerPoint presentation. She reviewed 2020 budget cuts and delays made to projects within Arts & Culture, the Equestrian Park, and Parks & Recreation.

Mr. Casper stated Community Services has taken a 17.5 percent budget reduction due to loss of revenue. This is the most of any County department and it is part of a \$100 million overall County budget reduction.

Board Member Camp asked about the termination of agreements.

Ms. Yocom stated future councils cannot be bound regarding termination of agreements. However, the Council voted to approve these projects. Once funding improves, the projects will be brought back.

Board Member Camp asked how many cities have spent funds and want reimbursement.

Ms. Yocom stated the County wants to help cities that have spent money as soon as funding becomes available.

Board Chair Bigelow stated revenue may be lower for the next several years. These projects may not be considered until much later, and along with other new requests.

Board Member McCay stated information from the Tracy Aviary was forwarded to the County on April 30, 2020.

Ms. Yocom stated she was not aware of that and will investigate it.

Board Member Overson asked that Ms. Yocom's presentation be forwarded to the Board Members.

Board Member McCay asked if \$25,000 could be removed from the Tracy Aviary.

Ms. Yocom discussed the status of contracts and payments. She will look

into this further.

Board Chair Bigelow stated until the County staff could research an item and provide additional information, he would be reluctant to add back in funding for any project other than what it has proposed at this point.
