#### Qualifications

Please tell us about yourself.

I retired in 2019 after working in the tourism industry for Visit Salt Lake for 32 years. I have two children 30 (in Denver) and 26 (in SLC), and one son-in-law. I was born in Topeka, Kansas, but spent most of my formative years in Kansas City, Missouri. My husband also worked in the hospitality industry, mainly in hotel management, and that is how we ended up in SLC 36 years ago (1987), and then chose to stay. He was the Director of Accommodations for the 2002 Olympics Salt Lake Organizing Committee, and is now responsible for getting all hotel contracts signed for the 2034 bid. Since retirement, I have become more involved in volunteerism, sitting on boards and committees, taking on one-time tasks for specific non-profits, and working with the community in support of social service and social justice issues.

With my background, both professionally and personally, I believe I have experience and knowledge in areas that would be beneficial to this particular County advisory council. I also feel a need to expand my volunteer work that targets social services issues.
