

2024 Sales Tax Revenue

- Projected based on local and national economic indicators, including
 - Wage and employment growth
 - Consumer Confidence
 - Vehicle sales and other leading indicators
- No new legislation but TRT impacted from Convention Center Hotel
- Information available from the Tax Commission on a two-month lag
 - Currently have actuals through March 2023
 - April information anticipated June 21st
- Projections vetted with the Revenue Committee
 - Rounding convention to nearest \$500K or \$100K









Zoo, Arts, & Parks Tax

(0.1% tax to ZAP Fund and General Fund*)











Transportation Sales Tax






Transient Room Tax

(4.25% tax to Visitor Promotion Fund*)












Transient Room Tax - Supplemental

(0.5% tax to TRCC: Tourism, Recreation, Cultural & Convention Fund)










Car Rental Tax

(3% & 4% tax to TRCC Fund)










Restaurant Tax

(1% tax to TRCC Fund)











Local Option Sales Tax


