## Qualifications

### Please tell us about yourself.

I moved from Washington DC to Salt Lake City in October 2019, to join our household with that of my wife's parents, who are older and one has dementia. I moved many years ago from Michigan to DC to work in policy, and later shifted my focus to urban revitalization, after getting involved in trying to improve my then neighborhood, which even in 2000, still showed the effects of 1968 riots. I read a lot, write a blog on most aspects of urban revitalization including parks planning and civic engagement (<http://urbanplacesandspaces.blogspot.com>), and enjoy the civic assets available to Salt Lake City residents by both the City and the County.



### Why are you interested in serving on a board or commission?

For almost 20 years I was heavily involved in urban revitalization in DC, moving from an avocation to working as a Main Street commercial district revitalization program manager, a bicycle and pedestrian planner in large suburban county, and as a consultant writing commercial district revitalization framework plans, selling bicycling facilities, etc. I served on boards and committees in the DC area: on the Eastern Market public market in DC, for 13 years, for Community Forklift, a building materials recovery and resale group (like Habitat for Humanity's Restore), and on community council committees for planning, and infrastructure. I joke that I might not be a good planner, but I am great at gap analysis, and gaps in DC's planning processes led me to develop great insights concerning planning in general, historic preservation, parks planning, planning civic assets as a network, library and cultural resources planning, etc. - <http://urbanplacesandspaces.blogspot.com/2021/07/five-examples-of-failure-to-do-parks.html>

### What education, work experience, or volunteer experience do you have that applies to the board you are applying for?

I have worked on various aspects of urban planning/urban revitalization for almost 20 years. Because of how DC has historically relied on the federal government to provide its parks and other cultural institutions, I became particularly interested in parks, public space, cultural resources, and library planning, and I have written about this extensively. I am especially interested in civic engagement around public assets like parks, libraries, and historic sites, "community cleanups" etc. as involvement devices (although by comparison to DC Salt Lake City is so clean!). Eg -- <http://urbanplacesandspaces.blogspot.com/2012/08/the-layering-effect-how-building-blocks.html?m=0> -- <http://urbanplacesandspaces.blogspot.com/2019/03/update-neighborhood-libraries-as-nodes.html> I also have a reasonably decent track record for successful grant writing, raising close to \$2MM in money and in-kind services.

### What unique perspectives could you bring to the board?

How local parks master plans need to take into account county and other assets. Co-location. Activation especially. When the idea of converting the garden center to a cafe was brought up, I wrote a long memo with ideas of how to better activate the park, including the potential of recapturing the Sizzler restaurant site for the park, for a welcome center, community space, and cafe. I shared that memo with Wayne Johnson when he was on the Park Authority, and more recently at the suggestion of Holly Nichols.

#### Please tell us about yourself.

I've lived one block away from Sugar House Park for the last six years. Like many of my neighbors, I feel that the park is an extension of our backyard. I've been working my full-time job from home since March 2020. I enjoy walking the park almost daily, through every season—from the spring with the baby ducklings to the winter sleds. I often take nieces and nephews there to enjoy the many amenities and features. In addition to being a destination, it's also a gateway and corridor: We ride bikes through the park to dine or shop around the Commons at the Sugar House area. Eight years ago, after college and working abroad, I moved back to Salt Lake City with a revitalized love and appreciation for the city and state. After a short time living downtown and in the south of this valley, we purchased a home in the Sugar House neighborhood. We enjoy the proximity to nature in our canyons, the west desert, and the short distance to Sugar House Park. The park's openness and proximity are a place of reprieve for me. It has become the spot to reset and connect to nature within the urban city. I love the park and I want to help sustain and preserve it for others to enjoy, forever.



**Why are you interested in serving on a board or commission?**

I want to join and serve the board and its members to maintain, manage, and sustain Sugar House Park. I believe there's a need for more individuals, including myself, to become involved in public policy— in small or large roles. We especially need more participation in our communities, reflecting the passions and knowledge of end-users, and I believe each individual brings something unique and beneficial to the discussion. I've been searching for my place to engage, and it feels serendipitous that my increased connection with the park over the last three years and the open seat on the board align. As a resident, I'm very interested to advocate and contribute to the park's Master Plan, including any park or community coordination with the rebuild of Highland High School. Both events will have a big impact on the neighborhood. I would be honored to serve with this group in the management and preservation of this incredible jewel in the Sugar House neighborhood.

**What education, work experience, or volunteer experience do you have that applies to the board you are applying for?**

My experience in organizational and mass communications will benefit the park board as we work on short-term and long-term objectives. In my management position, I coordinate groups within my organization as well as external teams to define objectives, build consensus, and complete tasks. My Bachelor's Degree in Digital Art and Design assists me in creating visuals to display information for discussion or to gather buy-in or agreement. If the Park Authority decides to conduct a new master plan, my five years of experience in the A/E/C (architectural, engineering, construction) industry could bring valuable insight to the process. In my profession, I work daily with requests for information (RFI) and requests for proposals (RFP) communication, management, and documentation. In addition to my education, I recently obtained the CPSM credential, which deepens my skill set in this area. It covers market research, marketing planning, client and business development, proposals, promotional activities, and management. I have knowledge of a wide range of skills and am organized, responsive, dedicated, and passionate. My volunteer experience includes teaching English as a second language and yoga instruction. I've been a licensed yoga teacher for 12 years.

**What unique perspectives could you bring to the board?**

As a millennial, I embrace technology, look for new perspectives, think outside the box, and am driven and motivated. I also bring a unique perspective from working within the design and construction industry. My experience with architects and urban and landscape planners has illustrated the huge importance of preserving green space for environmental benefits and the positive physical and emotional effects on people.
