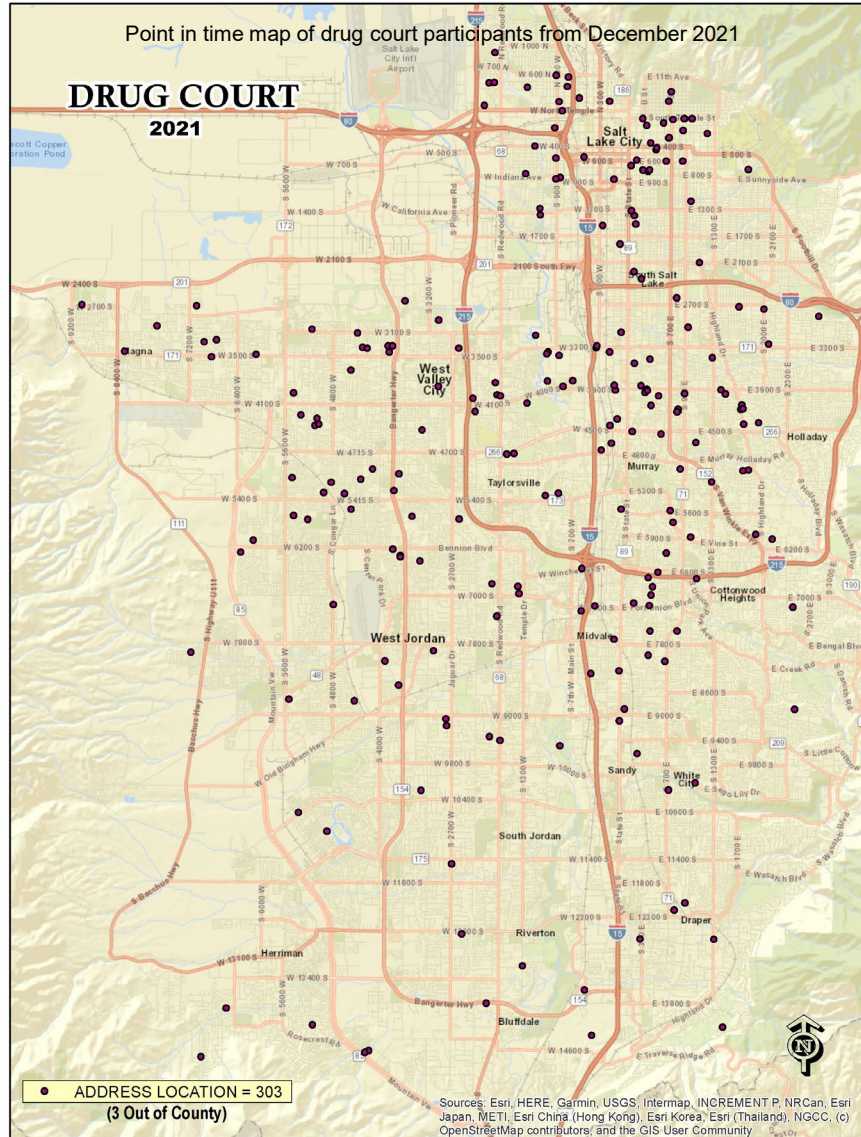

(Fugitive Apprehension) Unit**

DRUG COURT

Drug Court (including Veterans' Court) is an alternative to incarceration.



- Detectives are assigned to a specific judge and help manage a case load of 65+ clients each
- Manage 600-800 participants, who are technically in the custody of the Salt Lake County Sheriff's Office, annually
- Duties require law enforcement officer certification
- Includes Veterans' Court
- Duties:
 - Background checks
 - Housing support and checks
 - Drug tests
 - Treatment program enrollment
 - Individual support
- Staff:
 - 1 Sgt
 - 7 Detectives (avg. 65+ clients/per detective)



WARRANTS & EXTRADICTIONS

2022 Warrants/Extraditions/Pawns Activities

Extraditions back to 3 rd District	30
Active extraditable warrant investigations	153
Extraditions out of SLCo Jail	270
Total Pawn tickets collected	93,471*

*Pawn slips collected, logged, and maintained from 24 shops on 164,833 items pawned

Staff:

- 1 Sergeant
- 2.5 Detective Warrants/extraditions
- 0.5 Detective Pawn investigations

Statutory duty of the sheriff:

- Transport district court fugitives from outside the state
- Assist in arranging transport for district court fugitives from outside the county and country
- Arrange for the return of fugitives booked into SLCo Jail to the charging jurisdiction
- Review all third district court warrants and enter into NCIC
- Attend court proceedings for fugitives booked into SLCo Jail (3 days a week)
- Primary partner for state and federal agencies for entering fugitives into NCIC
- Pawn:
 - Includes all secondhand merchants**
 - Collect pawn tickets from 24 shops weekly
 - Monitor eBay and NCIC
 - Conduct large-scale multi-jurisdictional investigations

**Secondhand merchants include pawnshops, jewelry stores, metal shops, sporting good stores, and gun shops

- Primary partner in Utah for federal law enforcement agencies including the Marshall Service
- Host agency for the Marshall's VFAST (Violent Fugitive Apprehension Strike Team)
- Special certifications to utilize technology for investigations/apprehensions
- Owns cameras and other hardware that can be installed for and used by other law enforcement agencies upon request (usually fulfill requests within 24-48 hours)
- Responsible for executing SLCo DA VFAST warrants
- Human and electronic surveillance support for Metro Gang Unit, DEA Taskforce, federal agencies, etc.
- Evidence collection and processing for CW Cold Case Unit
- Assist CW Warrants/Extraditions Unit with investigations and arrests
- Supports SLCo Sheriff jail investigations
