Why do you want to serve on this board?

As a pediatric emergency medicine physician and Utah State Senator, I believe I can strongly support the mission of the CJC. I have worked on policy in this space and also have an understanding of the critical, important work you do.

I was nominated this year by Senate President Adams and Minority Leader Escamilla to serve as a national Child Welfare fellow with NCSL, and was selected as 1 of 25 lawmakers across the nation. I Would like to work alongside other community members to support the CJC and its mission as well as to Offer subject matter expertise if it may be helpful to the board. I firmly stand with the goal describing the CJC, "The Children's Justice Center is a safe place to experience support, protection, and healing."

What education, work experience, or volunteer experience do you have that applies to this board?

I am trained and certified as a pediatrician and an emergency medicine physician. I have MD and MPH degrees from the University of Utah, and have also trained at UCL and Indiana University. I have worked in the Emergency Department setting at Primary Children's Hospital for nearly 20 years where I have been involved with the care and evaluation of y0oung patients presenting with illness, injuries, mental health crises, and after experiencing physical and sexual abuse. I have worked in collaboration with the Safe and Healthy Families team at PCH and have worked on policy and legislation with them to support the protection of our kiddos and their families.

What unique perspectives could you bring to the board?

From a policy perspective, I worked as a non-elected advocate in the opioid overdose prevention space for nearly a decade prior to being elected. This allowed me to develop relationships broadly across the realms of law enforcement, the criminal justice system, physical and mental health care systems, as well as with policy makers. I feel I have a skill set that is helpful in advancing policy objectives and in building bridges.

From a care provider perspective, I have been involved with the care of children along their trajectory of being impacted by abuse, neglect and trafficking. I have evaluated them from a very initial presentation to years down the road as they continue to be treated and heal form their traumas. I feel I Bring a practical perspective to dialogues as well as a strong belief in the importance of what the CJC does for our kiddos.
