WHEREAS, UPD and Salt Lake County have not resolved all issues surrounding the departure but agree to an interim transfer of certain assets prior to that date in order for Salt Lake County to stand up its department on the above date, and

WHEREAS, this interim transfer of assets is based an agreement by both parties to reserve all issues for later determination. Some assets have been calculated to be part of the County Precinct. Other assets are in addition to the County Precinct and will be subject to payment by the County or an offset should the final calculation show that UPD owes Salt Lake County money upon final accounting. All assets have values attached.

NOW THEREFORE BE IT RESOLVED, that the UPD Board approves the attached list of assets to transfer to Salt Lake County prior to a resolution of all issues, subject to Salt Lake County possession and/or title of these items without warranty, express or implied from UPD, other than transferable manufacturers warranties that may be available and agreeing that the value of these assets and all other issues are reserved for later resolution, without prejudice to any claims or defenses either party may have.
