The Sheriff's Office is requesting 3 additional new FTE's to work on the further development of the Law Enforcement Bureau (LEB). The 3 FTE's are Lieutenant positions and have an anticipated start date of 4/28/2024. The request for funding in the current year and on-going will be covered by operating budget reductions from the UPD contract budget for the last half of 2024 (UPD transfer is expected to be completed by 7/1/24). The new FTEs will work with the existing LEB positions that were approved in 2023. They will support updating SO policies, hiring/onboarding, asset transfers, and vehicle readiness. Minor technical operating adjustments are included to support the new positions.
