**Ms. Dina Blaes**, Director, Office of Regional Development, delivered a PowerPoint presentation entitled 2025 Proposed Redevelopment Agency (RDA) Budget. She reviewed the budget summary; budget detail; FTE requests; and fee increases.

**Ms. Blaes** stated she received a letter from Adam Long, Attorney, Smith Hartvigsen PLLC, requesting the RDA to be transferred in 90 days. Based on past experiences with transferring RDA's to other jurisdictions, it takes

about a year to finalize. The RDA informed Magna City that the transfer was unable to happen in 90 days. The hope is to have the process expedited and finalized by the end of April.
