#### 2. PUBLIC HEARING

Mr. Todd Draper, Greater Salt Lake Municipal Services District, Planning & Development, delivered a PowerPoint presentation on what Olympia Hills Development is, its proposed location, density, the proposed land use plan, design standards, and the steps the development would have to follow for approval of each phase.

**Mr. Ivan Hooper**, Avenue Consultants, continued the PowerPoint discussing the traffic impact study, the study area, data collection absorption rates, and mitigation measures.

**Mr. Draper** concluded the PowerPoint presentation stating the Council will be considering approval of three applications: a general plan amendment, a zone change, and a P-C zone Master Development Agreement. The GSLMSD planning staff is recommending approval of all three components.

Mr. Bruce Baird, Legal Counsel, Olympia Hills Development, stated the developers of the proposed Olympia Hills Development have addressed all 13 concerns the Salt Lake County Council had regarding this development, as well as concerns of nearby residents. The project has specific requirements to address regional transportation solutions and the impact on water. This project provides for affordable housing so people can live there. The developers have also worked with the Jordan School District on the impact this development would have on schools in the area. People who move into this development would help pay for the needed schools.

Mr. Justin Swain, Utah for Responsible Growth, delivered a PowerPoint presentation stating the residents in the area support developments if they are done right. He reviewed concerns the residents have with this development, which include the Southwest Community Land Use Plan, which calls for no more than five units per acre, not the higher density of this proposal; the live, work and play concept; the Master Development

Agreement; transportation; environmental impacts; affordability; density; and possible solutions.

2.1 Public Hearing to Receive Public Comments Regarding the 20-0026 Hills Planned Development Community, including: 1) Amendment of the Southwest Community General Plan; 2) Amendment of the Salt Lake County Zoning Ordinance to Rezone **Property** Located at **Approximately** 6300-8500 W. 12400-13100 S. A-2 (Agricultural) and From and M-2(Industrial) to P-C (Planned Community); and 3) PC Zone Plan/Master Development Agreement.

### Council Member Burdick opened the public hearing.

project The following citizens spoke in opposition to the proposed expressing concern because of increased taxes, the high density of the project, infrastructure not in place, increased volume of traffic, utilities, lack of public transit, impact fees, air quality, setting of precedent for other areas, opposition surrounding unincorporated by cities, emergency evacuation issues, and possibility of mining operations.

Citizens also noted the need for open space and affordable and senior housing. The development is inconsistent with the Southwest General Plan and it allows the developer to walk away from the project at any time. Council Members should wait for the Southwest Visioning Study and listen to residents before voting on this issue.
