- RFP issued fall of 2024
- RFP selection committee unanimously selected Civic Plus Agenda and Meeting Management



# Pros of the Civic Plus System

- Entirely web browser based
- Compatible with multiple operating systems
- More modern and user-friendly interface
- Single Sign On with County Credentials  
(remember to use .gov email address)



# Transition Timeline

- Projected to “go live” with Civic Plus for the June 3<sup>rd</sup> Council meeting
- Parallel period with both Civic Plus (primary) and Granicus (backup)
  - Users will be required to submit agenda items in both systems during the parallel period
- County Sharepoint site with training resources and FAQ
- Announcement to the Public on Council website and social media
