Members of the Municipal Building Authority may participate electronically. The public may attend. Meetings may be closed For reasons allowed by statute. Motions relating to any of the items listed below, including final action, may be taken.

Due to the ongoing public health emergency related to the COVID-19 pandemic and response, public gatherings have been limited to less than 20 persons and public access to the Salt Lake County Government Center has been limited on the orders of the Salt Lake County Mayor.

Consistent with Salt Lake County Council Resolution 5714, approved March 24, 2020, the Salt Lake County Municipal Building Authority has made preparations to conduct its meetings electronically. In light of current public health orders and social distancing requirements, the Municipal Building Authority cannot provide physical space or facilities for members of the public to attend its meetings for the duration of the public health emergency.
