Andrew Gruber, Executive Director of Wasatch Front Regional Council
(Approx. 20 min.)

Mr. Andrew Gruber, Executive Director, Wasatch Front Regional Council (WFRC), delivered a PowerPoint presentation reviewing Utah's population growth, 80 percent of which is and will be along the Wasatch Front, and the challenges of transportation, i.e. the time it takes to commute to and from work, air quality, decreased access to opportunity, and crowding on roads and in national parks. He also

reviewed WFRC's Wasatch Choice 2050, a regional vision for transportation, land use housing, economic development, and air quality, including the vision process, four key strategies, and the expected outcomes. The four key strategies include providing transportation choices, i.e. reliable transit and active transportation, supporting housing options, preserving open space, and linking economic development with transportation and housing decisions.

Mr. Ted Knowlton, Deputy Director, reviewed the housing challenge explaining demand is exceeding supply and there is little vacant land along the Wasatch Front, so housing is more expensive. The key strategy to support housing options includes more single and multi-family housing, and growth around housing centers.

Council Member Snelgrove stated transportation options should include Uber and Lyft.

Salt Lake Community Action Program, a Utah non-profit corporation (“SLCAP”), has historically leased a small amount of office space in the Redwood Multi-Purpose Center at no cost for its HEAT program, and has requested a new no cost lease for another five years.

NOW, THEREFORE, IT IS HEREBY RESOLVED, by the Salt Lake County Council that, as provided in Utah Code Ann. § 17-50-303(3)(a)(2018), the Salt Lake County Council has determined that SLCAP, as a non-profit entity whose services contribute to the moral well-being of County inhabitants, shall not pay a fee or other monetary consideration for the leased space used for its HEAT program; and that the attached lease is hereby approved; and the Mayor and Clerk are hereby authorized to execute said license, a copy of which is attached hereto, and by this reference made a part of this Resolution.

RESOLUTION NO. 5403

A RESOLUTION OF THE COUNTY COUNCIL OF SALT LAKE COUNTY APPROVING AND AUTHORIZING EXECUTION OF AN INTERLOCAL COOPERATION AGREEMENT BETWEEN SALT LAKE COUNTY AND THE CITY OF COTTONWOOD HEIGHTS FOR A CONTRIBUTION OF TRCC FUNDS TO HELP FINANCE THE PURCHASE AND INSTALLATION OF ADDITIONAL LIGHTING EQUIPMENT USED FOR PROGRAMS AND CONCERTS AT THE BUTLER MIDDLE SCHOOL AUDITORIUM

RECITALS

A. Salt Lake County (the “County”) and the city of Cottonwood Heights (the “City”) are “public agencies” as defined by the Utah Interlocal

Cooperation Act, Utah Code Ann. §§ 11-13-101 et seq. (the “Cooperation Act”), and, as such, are authorized by the Cooperation Act to enter into this Agreement to act jointly and cooperatively on the basis of mutual advantage in order to provide facilities in a manner that will accord best with geographic, economic, population and other factors influencing the needs and development of local communities.

B. The County receives funds (“TRCC Funds”) pursuant to the Tourism, Recreation, Cultural, Convention, and Airport Facilities Tax Act, Utah Code Ann. §§ 59-12-601 et seq. (the “TRCC Act”). The TRCC Act provides that TRCC Funds may be used, among other things, for the development, operation, and maintenance of publicly owned or operated recreation, cultural, or convention facilities.

C. In 2017, the City requested TRCC Funds from the County--through the County’s Cultural Facilities Support Program--to help it fund the project described in its Cultural Facilities Support Program Application. More specifically, the City requested TRCC Funds to help finance the purchase and installation of additional lighting equipment used for programs and concerts at the Butler Middle School Auditorium (the “Project”). The County Council appropriated TRCC Funds for this purpose in the 2018 Salt Lake County Budget.

D. The City and the County now desire to enter into the Interlocal Cooperation Agreement attached hereto as ATTACHMENT A (the “Interlocal Agreement”) wherein the County agrees to grant TRCC Funds to the City to help fund the Project and wherein the City agrees to abide by the terms and conditions outlined in the Agreement.

E. The County Council believes that its contribution and assistance under the Agreement will contribute to the prosperity moral well-being, peace and comfort of Salt Lake County residents.

RESOLUTION

NOW, THEREFORE, IT IS HEREBY RESOLVED, by the County Council of Salt Lake County:

1. That the Interlocal Agreement between Salt Lake County and the city of Cottonwood Heights is approved, in substantially the form attached hereto as ATTACHMENT A, and that the Salt Lake County Mayor is authorized to execute the same.
2. That the Interlocal Agreement will become effective as stated in the Interlocal Agreement.
