As you recall, we have been in the process of reviewing and interviewing the applicants for the UTA Board of Trustees position representing Salt Lake County. We completed an open call for applications asking individuals to provide their resume and answers to approximately five (5) questions related to their skills, abilities, and background to lead an organization in transition such as UTA.
