AGREEMENT BETWEEN SALT LAKE COUNTY AND COMMUNITIES UNITED

RESOLUTION NO. _____, 2020

A RESOLUTION OF THE COUNTY COUNCIL OF SALT LAKE COUNTY APPROVING AND ADOPTING AN AGREEMENT EXECUTED BETWEEN THE COUNTY AND COMMUNITIES UNITED, A 501(c)(3) NON-PROFIT TO PROVIDE \$50,000 TO COMMUNITIES UNITED TO BE DISBURSED TO FAMILIES IMPACTED BY THE COVID-19 PANDEMIC.

WHEREAS, Salt Lake County, through the Office for New Americans, has received a \$50,000 grant from the Charles and Lynn Schusterman Family Foundation to provide direct financial relief to families who have been most impacted by the COVID-19 pandemic in Salt Lake County.

WHEREAS, Communities United (“CU”) is a 501(c)(3) organization dedicated to building healthy and united families within the local community;

WHEREAS, the Salt Lake County Council has adopted countywide policy 1200, which allows Salt Lake County to provide money or in-kind assistance to a non-profit if the council determines that it will further the health, safety, and welfare of county citizens consistent with the County’s policy priorities and objectives;

WHEREAS, CU has offered to assist in distributing the \$50,000 grant to needy families impacted by the COVID-19 pandemic within Salt Lake County;

WHEREAS, providing fifty thousand dollars (\$50,000) to CU for the purposes of distributing it to needy families impacted by the COVID-19 pandemic will aid in fulfilling the

purposes for which Salt Lake County received the funds and will further the health, safety, and welfare of county citizens;

WHEREAS, such an agreement has been prepared, is attached hereto, and is agreeable to the parties;

NOW, THEREFORE, BE IT RESOLVED:

1. THAT the county council of Salt Lake County, Utah, hereby approves the attached agreement between Salt Lake County and Communities United whereby fifty thousand dollars (\$50,000) will be provided to Communities United to distribute to needy families within Salt Lake County that have been impacted by the COVID-19 pandemic.
