2019 Tax Year for Indigent and Hardship Relief
(Recommend Approval)

Council Members:

The Property Tax Committee, at a meeting on November 15, 2018, considered updating the Indigent/Hardship sliding scale for 2019. The Committee recommends the attached scale be approved for use in administering indigent and hardship relief for 2019. The scale uses the same income guidelines as the State Circuit Breaker program. Assets are added to income to determine the total resources available to a household. The actual amount of relief is determined after considering the total number of people in the household. The 2019 sliding scale does not include a burial allowance to more accurately reflect the resources available to a household.
