#### Please tell us about yourself.

I am Special Assistant to the President for Campus-Community Partnerships at he University of Utah and the Director of University Neighborhood Partners https://www.partners.utah.edu/, a department of the U that is geographically located in the west side of Salt Lake County. We work to build partnerships around community identified priorities. We have a network of around 75 partnerships with 129 community leaders. I have been in this position for 5 years. Health and SDOH are the most common community prorities. Prior, I served as a teacher and school administrator for 23 years.
