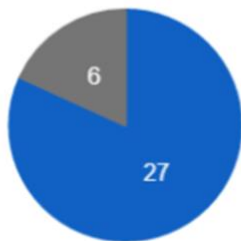

Improve the ability of the business to collaborate and communication with each other and their customers.

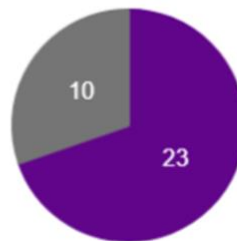
Collaboration vs Non-Collaboration Projects

Improve the ability of the businesses solutions to integrate and communication with each other and their customers solutions.

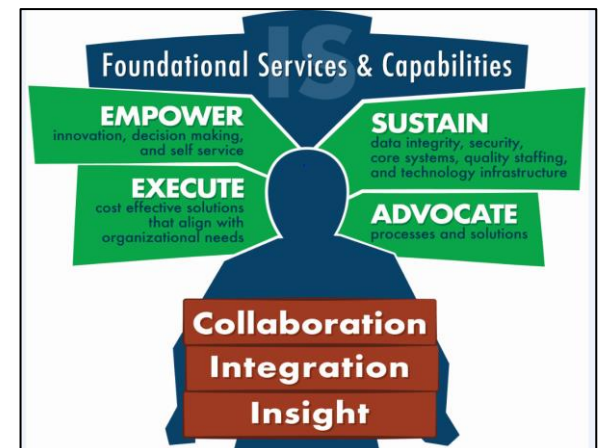
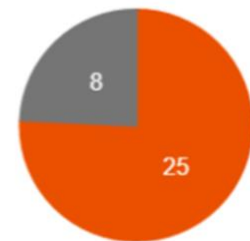
Integration vs Non-Integration Projects



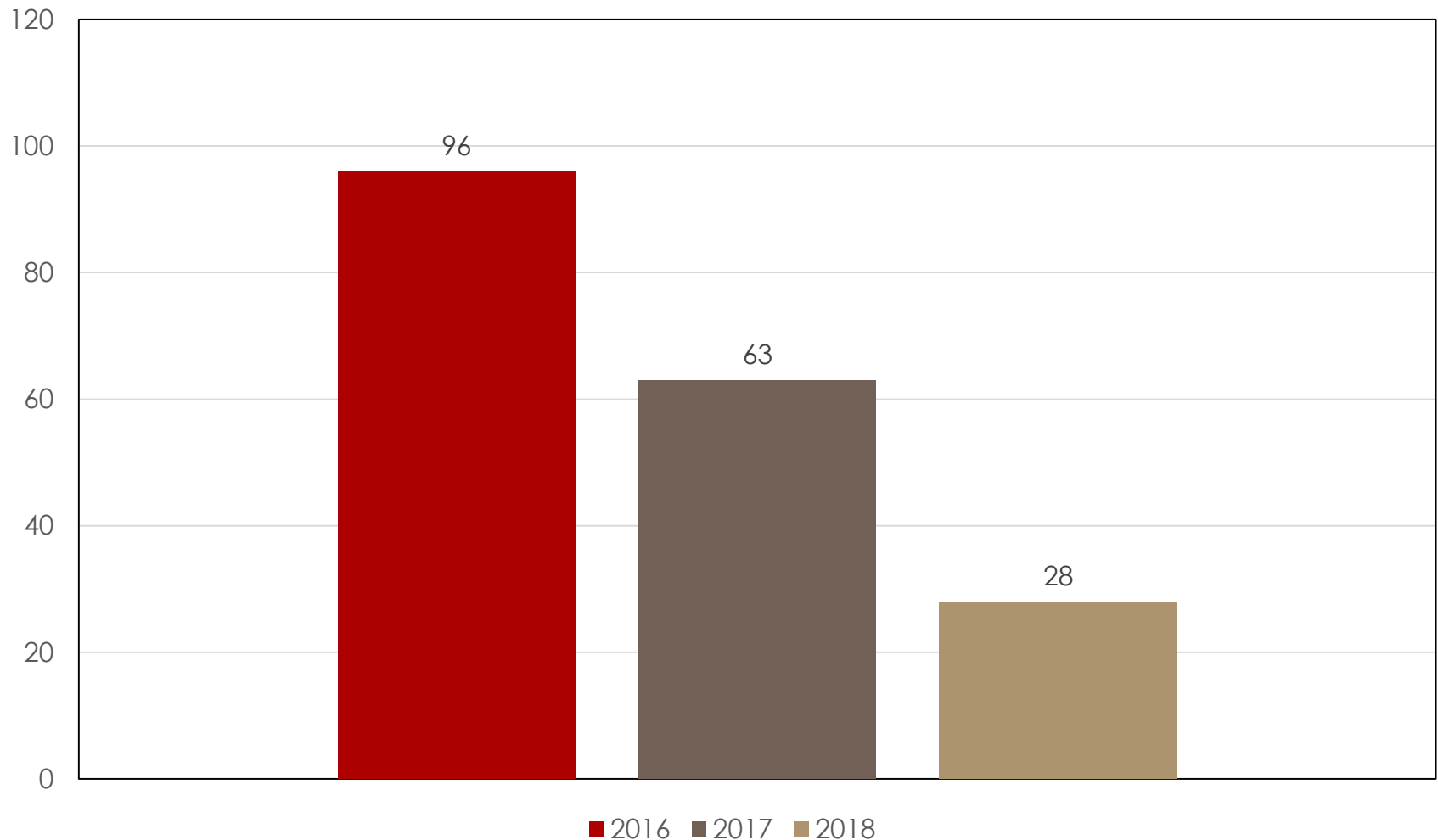
Insight -

Provides tools and support to allow the businesses to find and share (with each other and their customers solutions) information to support better decision making.

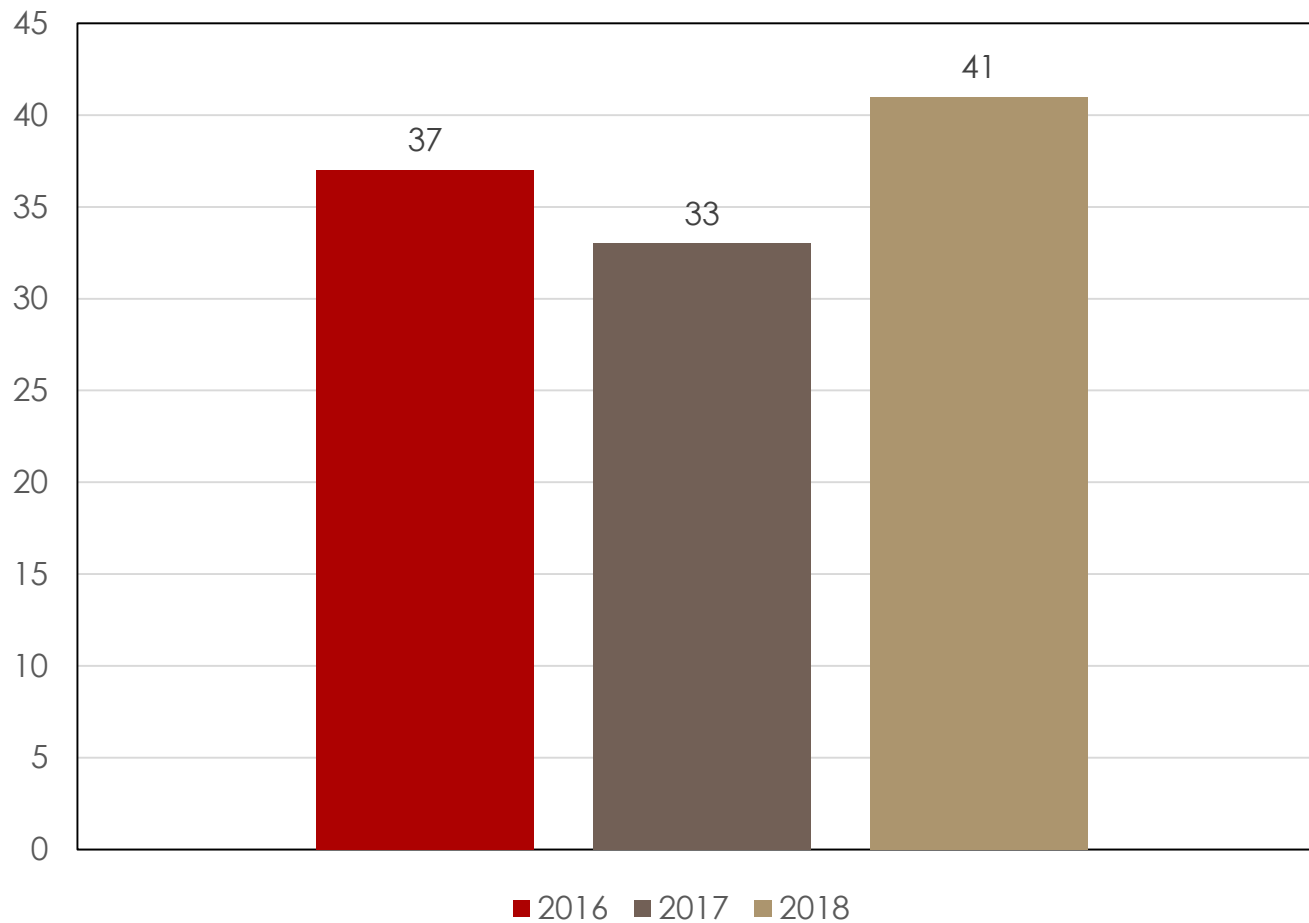
Insight vs Non-Insight Projects

IT Capital Fund Proposal

(General Fund Eligible)

- Requests for New One Time Funding to Implement IT Effort(s)
- Similar to the model followed by Facilities Capital Fund
- Add simplicity to the Budget process for TAB by categorizing priorities
- Larger projects will get more attention with time in TAB
- Smaller projects will not get eclipsed by larger projects
- Value added projects not skipped over by risk driven projects
- Left over funding is able to be shifted to other projects
