RESOLUTION NO. 5800

A RESOLUTION SETTING FORTH MAXIMUM OPERATIONAL CAPACITY FOR THE SALT LAKE COUNTY JAIL

WHEREAS, Utah Code Annotated, Section 17-22-5.5 authorizes the Sheriff to establish a maximum operating capacity of each jail facility with the approval of the County legislative body; and

WHEREAS, the Sheriff currently operates the County’s Jail Facility which consists of the Salt Lake County Adult Detention Center and Oxbow Jail; and

WHEREAS, Utah Code provides that with the approval of the County Council the Sheriff shall set a maximum operating capacity for each jail facility based on the facility design and staffing; and

WHEREAS, Utah Code Annotated Section 17-22-5 authorizes the Sheriff to implement written policies for admission of prisoners and classification of incarcerated person in the jail for the safety and well-being of the prisoners and the community prior to and in conjunction with the maximum operating capacity.

RESOLUTION

NOW, THEREFORE the County Council of Salt Lake County resolves that under the current design and staffing, the maximum operational capacity of the Salt Lake County Jail Facility is two thousand one hundred sixty-five (2,165). The maximum operating capacity may be temporarily reduced by the number of unavailable beds when a unit is closed for repairs, due to staffing or other administrative necessities. Upon reaching the maximum operating capacity, the Sheriff shall take appropriate measures allowed by law.

Further, when the prisoner population reaches 80% of the maximum operating capacity the Sheriff shall apply the uniform written policies for admission of prisoners as allowed by law for the safety and well-being of inmates and the community.

RESOLUTION NO. 5801

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL APPROVING AN INTERLOCAL COOPERATION AGREEMENT BETWEEN SALT LAKE COUNTY AND MILLCREEK FOR THE LEASE OF CERTAIN PROPERTY LOCATED IN MILLCREEK, UTAH

RECITALS

- A. Salt Lake County (the “County”) owns a semi-improved parcel of real property located at 3330 South 1300 East, Millcreek, Utah, also identified as Parcel No. 16-27-201-034 (the “Property”).
- B. The Property was conveyed to Landlord pursuant to a quit claim deed (“Quit Claim Deed”) from the Utah Department of Transportation and is subject to various restrictions contained in the Quit Claim Deed, including that the Property can only be used for the benefit of the general public.
- C. Millcreek (the “City”) would like to lease the Property from the County subject to the restrictions in the Quit Claim Deed.
- D. The County and the City have negotiated a Lease Agreement, attached as Exhibit A hereto, to provide for the lease of the Property to the City for a term of twenty-five years.
- E. The City shall, at its own expense, be responsible for all maintenance, repairs, and improvements to the Property and shall pay the County one dollar (\$1) a year in exchange for the lease of the Property.
- F. It has been determined that the best interests of the County and the general public will be served by executing the Lease Agreement for the lease of the Property upon the terms and conditions contained therein.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake

County Council that the attached Lease Agreement, attached hereto as Exhibit A and by this reference made a part of this Resolution, is hereby approved; and the Mayor is hereby authorized to execute said Lease Agreement.

RESOLUTION NO. 5802

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL APPROVING AN INTERLOCAL COOPERATION AGREEMENT BETWEEN SALT LAKE COUNTY AND WASATCH FRONT WASTE AND RECYCLING DISTRICT FOR THE LEASE OF CERTAIN SPACE AT THE SALT LAKE COUNTY PUBLIC WORKS DEPARTMENT COMPLEX.

RECITALS

- A. Salt Lake County (the “County”) owns several parcels of real property

located at approximately 605 West 6960 South (the “Administration Parcel”) and 7125 South 600 West (the “South County Parcel”), Midvale, Utah, known as the Salt Lake County Public Works Department Complex (the “Complex”), including the Salt Lake County Public Works administration building (the “Administration Building”).

B. The Wasatch Front Waste and Recycling District (the “District”) owns two parcels adjacent to the South County Parcel - one parcel is located at 7062 South 600 West (the “South District Parcel”), and one parcel is located at 7125 South 600 West (the “Employee Parking Parcel”).

C. The District desires to lease a portion of the Complex, including office space in the Administration Building together with a right to use portions of the Administration Parcel (“Leased Property”).

D. Additionally, the County and the District wish to jointly use the South County Parcel, the South District Parcel, and the Employee Parking Parcel.

E. The County and the District have negotiated an Interlocal Cooperation Agreement, attached as Exhibit A hereto, to provide for the lease of the Leased Property and for the joint use of the other parcels.

F. It has been determined that the best interests of the County and the general public will be served by executing the Interlocal Cooperation Agreement for the lease of the Leased Property and joint use of the other parcels upon the terms and conditions contained therein.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the attached Interlocal Cooperation Agreement, attached hereto as Exhibit A and by this reference made a part of this Resolution, is hereby approved; and the Mayor is hereby authorized to execute said Interlocal Cooperation Agreement.
