Description and Justification:

Wheeler Farm Outdoor Education Center: Parks & Recreation has initiated a project to build an outdoor education center at Wheeler Farm as part of the 2017 Park & Recreation Bond. Due to rising construction costs, the bids received exceed original estimates. Parks & Recreation requests a fund balance transfer from TRCC in order to ensure sufficient budget to award construction contracts. The fund balance transfer represents two 2019 projects (Wheeler Farm gravel pathway improvement and Wheeler Farm garage restoration) whose scope will be added to the Wheeler Farm Outdoor Education Center project scope (\$130,000) and re-directed 2019 TRCC funding from the Valley Regional Park Ph.2 project (\$213,964).
