Re: **Consideration of 2018 Veteran Exemption After the Sale of the Property or Other Change in Ownership After the Lien Date for Patrick D. Osmond, Parcel # 32-12-129-033**

Council Members:

The Property Tax Committee, at a meeting on February 14, 2019, considered an application for 2018 Veteran Exemption due to the sale of the property or other change in ownership, after the lien date. The Committee recommends that the following relief be granted:

Action	Type of Relief	Amount of Relief
Approve	Veteran Exemption	\$ 2,434.32

The refund formula for Veterans Exemption tax relief may be found in Utah statute 59-2-1105. A county granting an abatement, credit, or exemption to a claimant shall refund to that claimant an amount equal to the amount by which the claimant's property taxes paid exceed the claimant's property taxes due if that amount is \$1 or more. State Tax Commission appeal # 17-2022 further defines a claimant's property taxes paid to be the sum of property taxes the claimant paid plus the amount of their tax relief credit or abatement and does not include amounts paid by a third party such as a buyer. If the claimant feels the County has improperly processed their request for Veterans Exemption tax relief, they may appeal to the Utah State Tax Commission. The appeal must be filed within 30 days of this notification. The appeal should be filed with Council-Tax Administration, who will forward the appeal to the State Tax Commission.
