THIS BEING THE TIME heretofore set to canvass the official election results for the 2020 General Election.

Ms. Sherrie Swensen, County Clerk, stated this election was a monumental task. There was an increase of 100,000 voters since 2016, and 93,000 since Election Day 2018. This election, there were 610,218 active registered voters, and a turnout of 90.11 percent with 549,882 ballots cast. Of those, 51,411 were in-person ballots, and 498,471 were mail-in ballots.

There were some individuals concerned about the wait times to get the results, but there is always a two-week canvassing period to make sure every ballot gets processed and every eligible vote counted. This year, people working in the ballot center also had to social distance.

She submitted the final results for the 2020 General Election to be certified by the Board of Canvassers, including the write-in results. The lists are made part of the minutes by reference.
