Member shall be limited to no more thatn three consecutive terms each.

HTFAB shall consist of nine appointed members, at least two of whom qualify for affordable or special needs housing benefits. Six members shall have expertise or experience in one or more of the following six areas: urban desing, public asset management, architecture, urban planning, housing services/development, and economics.
