In 2020, an account was created for Kin Sen Asian Noodle Bar. A declaration request was sent to the taxpayer with no response. After subsequent notices and the closing of their filing window their personal property value was estimated, and a penalty added. Upon further evidence provided by the taxpayer, the business was found to not be in the location or to have opened until after the lien date of January 1st, 2020, which eliminates their filing requirement for 2020.

The penalty has now been removed from the account. The Assessor's office respectfully requests your permission to abate the 2020 personal property taxes in the amount of \$974.70. based on a taxable value of \$75,000, along with any accrued interest.
