
Utah Schools participating in the School LAND Trust program are required by Utah Code to have school community councils to advise on the use of School LAND Trust funding. I am the chair of the School Community Council (SCC) for Emerson Elementary in the Salt Lake City School District. Emerson Elementary School's SCC meetings are once a month and occur outside usual business hours. Councilmembers are nonpartisan and serve a one- or two-year term. The council's business pertains to the function of the school and the school community. Sometimes councils lead projects to improve the safety of students who attend the school, such as contacting the city to request better signage for a crosswalk. It is possible, though highly unlikely, that the Emerson Elementary SCC could take up an issue related to County Services provided at the school or in the neighborhood. If such an occasion rises, I will recuse myself from the project and any decisions related to it.
