### HB 374 County Sheriff Amendments (Rep. Jordan Teuscher)

This bill prohibits, with certain exceptions, a county sheriff and the sheriff's deputies, in a county of the first class, from directing or acting as an employee or chief executive for an entity, other than the county sheriff's office, that provides law enforcement services under an interlocal agreement; and requires county funds to be used for county-wide benefits and services.
