ORDINANCE NO. _____, 2023

AN ORDINANCE APPROVING SOUTHWEST CANAL AND CREEK
HYDROLOGY STUDY

The County legislative body of Salt Lake County, State of Utah, ordains as follows:

WHEREAS, due to the pace of new development throughout Salt Lake County it has become apparent that the studies that address storm drainage and flood control development need to be updated to reassess predevelopment stormwater release rates and how those rates will impact the County's Flood Control Facilities;

WHEREAS, the Southwest Canal and Creek Hydrology Study has recently been completed;

WHEREAS, this study addresses a number of issues, including but not limited to, the maximum excess water release rates into storm drain systems that are allowed for new development projects in the unincorporated county, i.e., the amount of stormwater that a developer must retain onsite via stormwater facilities that a developer constructs;

WHEREAS, pursuant to Utah Code section 17-27a-212, a public hearing is required before Salt Lake County can approve this study for the affected unincorporated portion of the County;

WHEREAS, the Salt Lake County Council held a public hearing for this matter on March 28, 2023; and

NOW THEREFORE, the Salt Lake County Council hereby approves the Southwest Canal and Creek Hydrology Study. A copy of this Study is included in the QR Code inserted herein and is incorporated as if fully set forth.

This ordinance shall take effect fifteen (15) days after its passage and upon at least one publication in a newspaper published in and having general circulation in Salt Lake County, and if not so published within fifteen (15) days then it shall take effect immediately upon its first publication.
