A motion was made by Council Member Stewart, seconded by Council Member Stringham, to close the Council Work Session to discuss security personnel, devices, or systems. The motion carried by a unanimous vote.

The Council voted to reopen the Committee of the Whole meeting during the closed session.

**Ms. Megan Hillyard**, Director, Administrative Services Department, stated a lot of questions arose in early December when the Governor made an announcement about TikTok. Information Services has reviewed the issues with TikTok and will brief the Council on that.

**Mr. Zachary Posner**, Chief Information Officer, Information Services Division, delivered a presentation on the Tik Tok situation, which included an overview of TikTok, and a history of the events that had occurred from October 20, 2022, when Forbes first reporting that TikTok was using location data to surveil United States (US) citizens and the Department of Treasury opened an investigation, to December 2022, when Chris

Wray, Director, Federal Bureau of Investigation (FBI), expressed concerns about the potential misuse of the TikTok app; Governor Spencer Cox announced that China's access to data collected by TikTok could present a threat to Utah's cybersecurity; Utah's Statewide Information & Analysis Center's (SIAC) noticed its concerns about algorithmic influence and the use of bots; and the Federal Executive branch and US House of Representatives banned the use of Tik Tok on their devices. He also reviewed the risks, which were low for malware, but high for the potential of influencing public opinion or officials, as well as information leakage through the collection and misuse of information. TikTok was not doing anything different than what other social media organizations were doing, in that they were all collecting data, using algorithms to direct traffic, and know global positioning locations (GPS), but TikTok is owned by a China based company, and under Chinese law, the Chinese government can step in at any time and gain total access to the data. Only one or two agencies in the County are actively using TikTok, including the Salt Lake County Health Department, although others were exploring it to reach out to constituents. He was not sure an outright ban on County devices was necessary, but he wanted the Council to be aware of the risks.

**Council Member Stringham** stated she was willing to make a motion to ban TikTok because of security issues identified by Governor Cox and some additional information she learned from researching. If a specific organization wanted to use it, they should use it on a device that would not put the County at risk.

**Mayor Jennifer Wilson** stated before the Council implemented a ban on TikTok, she would want time to discuss this with the County organizations using it to find out what their arguments might be for using it. There are pros and cons with any social media, and the pros for using TikTok might outweigh the risks.

**Mr. Mitchell Park**, Legal Counsel, Council Office, recommended the Council not take a vote on a ban today because it was not noticed on the agenda, but to instead bring it back next week to ensure it is properly noticed.

A motion was made by Council Member Stringham, seconded by Council Member Theodore, to approve legislative intent to look at the TikTok issue and ask organizations currently using it to get information back to the Council about their use, and to come back in a week and determine the best action. Council Member Winder Newton amended the motion to come back in a week or two to ensure everyone had enough time.

**Council Member Harrison** stated at the next presentation, she would like to see ways to mitigate risk with any social media the County may choose to use.

**Mayor Wilson** stated her office could handle the review of the TikTok issue, but she would need several weeks for a broader review of social media policy.

**Ms. Catherine Kanter**, Deputy Mayor of Regional Operations, asked if the expectation was for staff to come back with information, and that any agency utilizing TikTok should be prepared for answering what content they were putting on the platform, the reason they chose TikTok, and if an alternative social platform could serve the intended purpose.

**Council Member Stringham** stated that was what the Council wanted so it could understand how and why agencies were using it.

A motion was made by Council Member Stringham, seconded by Council Member Theodore, to approve legislative intent to look at the TikTok issue and ask organizations currently using it to get information back to the Council about their use, and to come back in a week and determine the best action. Council Member Winder Newton amended the motion to come back in a week or two to ensure everyone had enough time. The motion carried by a unanimous vote.
