RE: REINSTATEMENT OF DEFERRAL - MAY 2019 TAX SALE

> Mukhtar, Muhammad, Parcel # (ACN) 16-31-382-043, Category 202 (Recommend Approval with Conditions, effective 5/13/2019)

## Council Members:

The Property Tax Committee, at a meeting on May 16, 2019, reviewed an application for reinstatement into the tax deferral program. The total delinquency of \$4,416.09, as of 5/13/2019, includes real property tax delinquencies plus penalties, interest, and administrative fee. A payment of \$1,350.00 has been deposited with the Salt Lake County Treasurer and credited to a suspense account. The Committee recommends that the delinquent balance be deferred subject to the following terms:

- 1. Funds in the suspense account to be applied to the delinquency;
- 2. Continued monthly payments, increased to \$150.00, applied to the delinquency;
- 3. All subsequent taxes be paid on or before the due date annually;
- 4. The participant retain their ownership interest in the property during the entire deferral period;
- 5. The property remain occupied during the entire deferral period as the participant's primary residence;
- 6. Yearly submission of an Application for Tax Abatement on or before the filing deadline;
- 7. The deferral be reviewed annually prior to the Tax Sale for compliance with the terms.

Failure to comply with the terms above may result in revocation of the deferral agreement with the total delinquency due immediately.

With the deferral in place, the County Treasurer may remove the Tax Sale Administrative fee of \$250.00, and the County Auditor may withdraw the property from the May 2019 Tax Sale.
