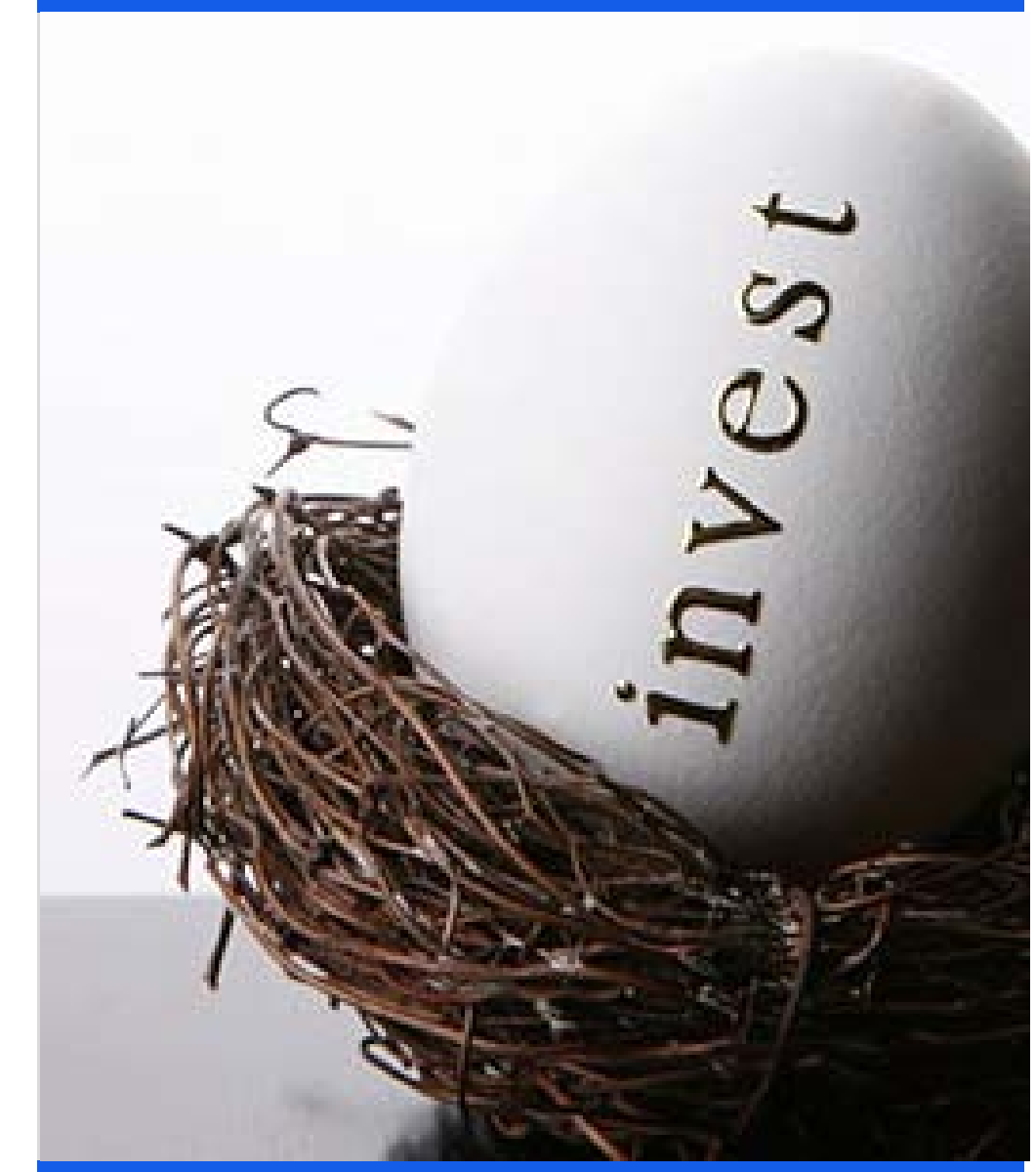

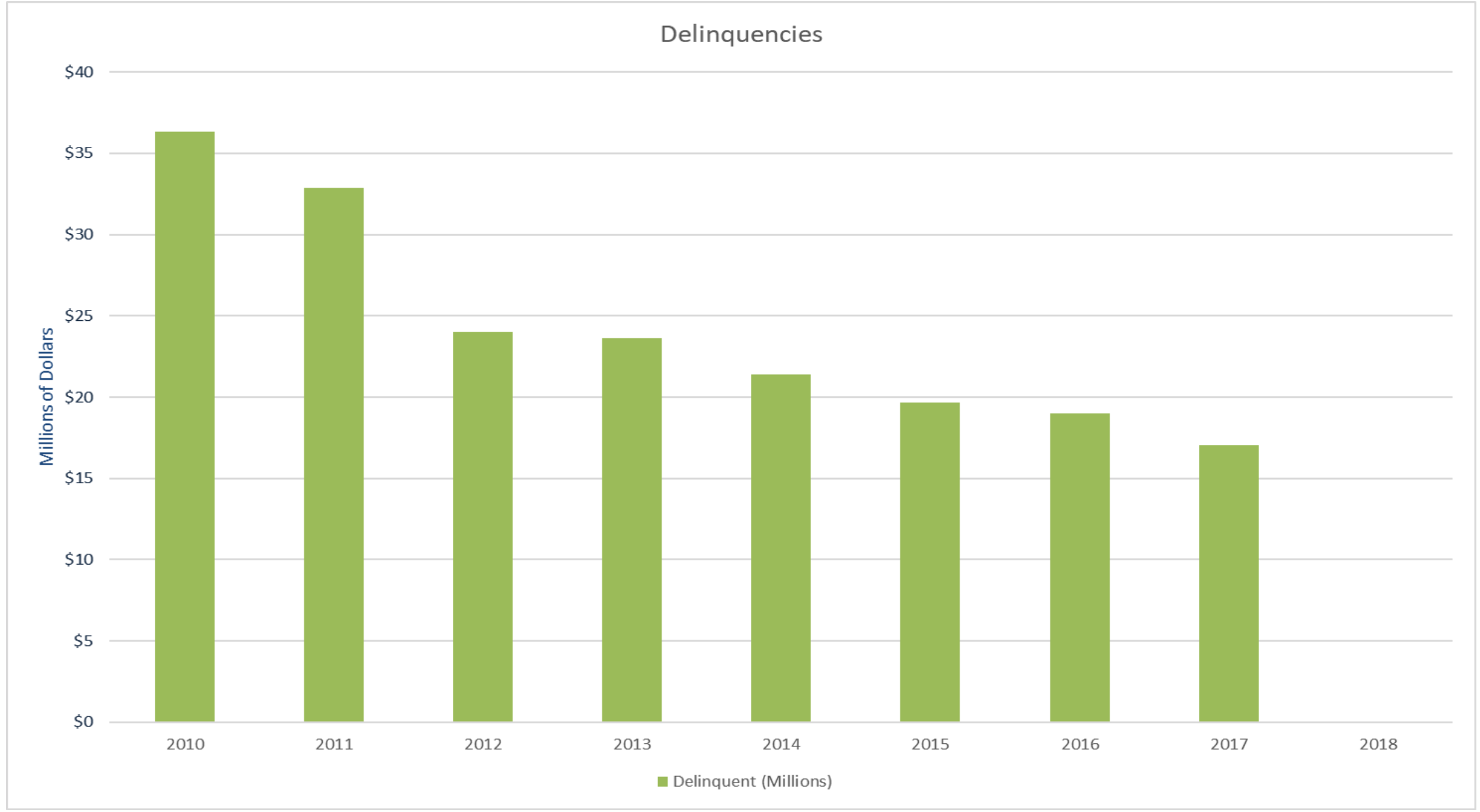
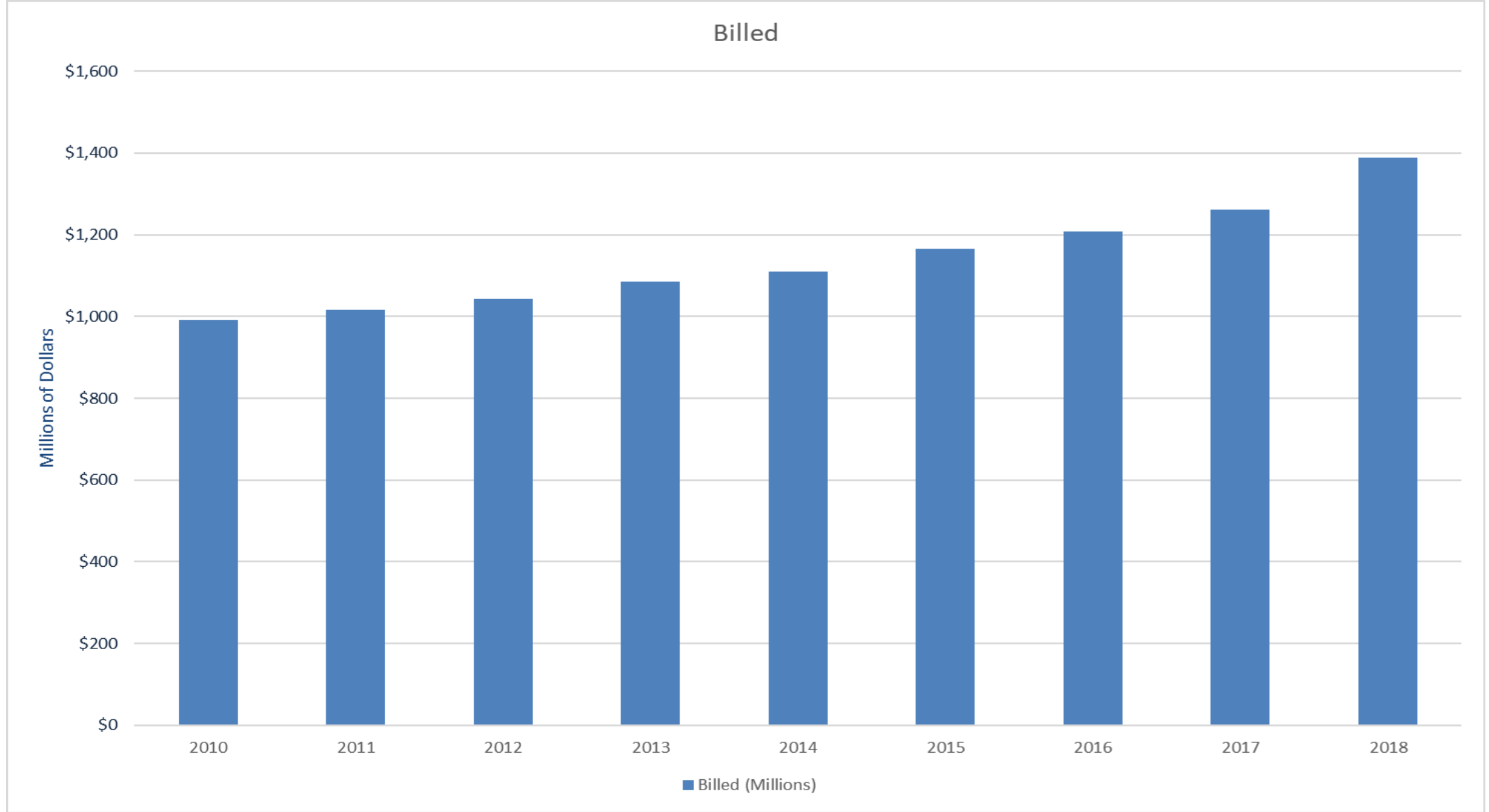

2010 to 2017

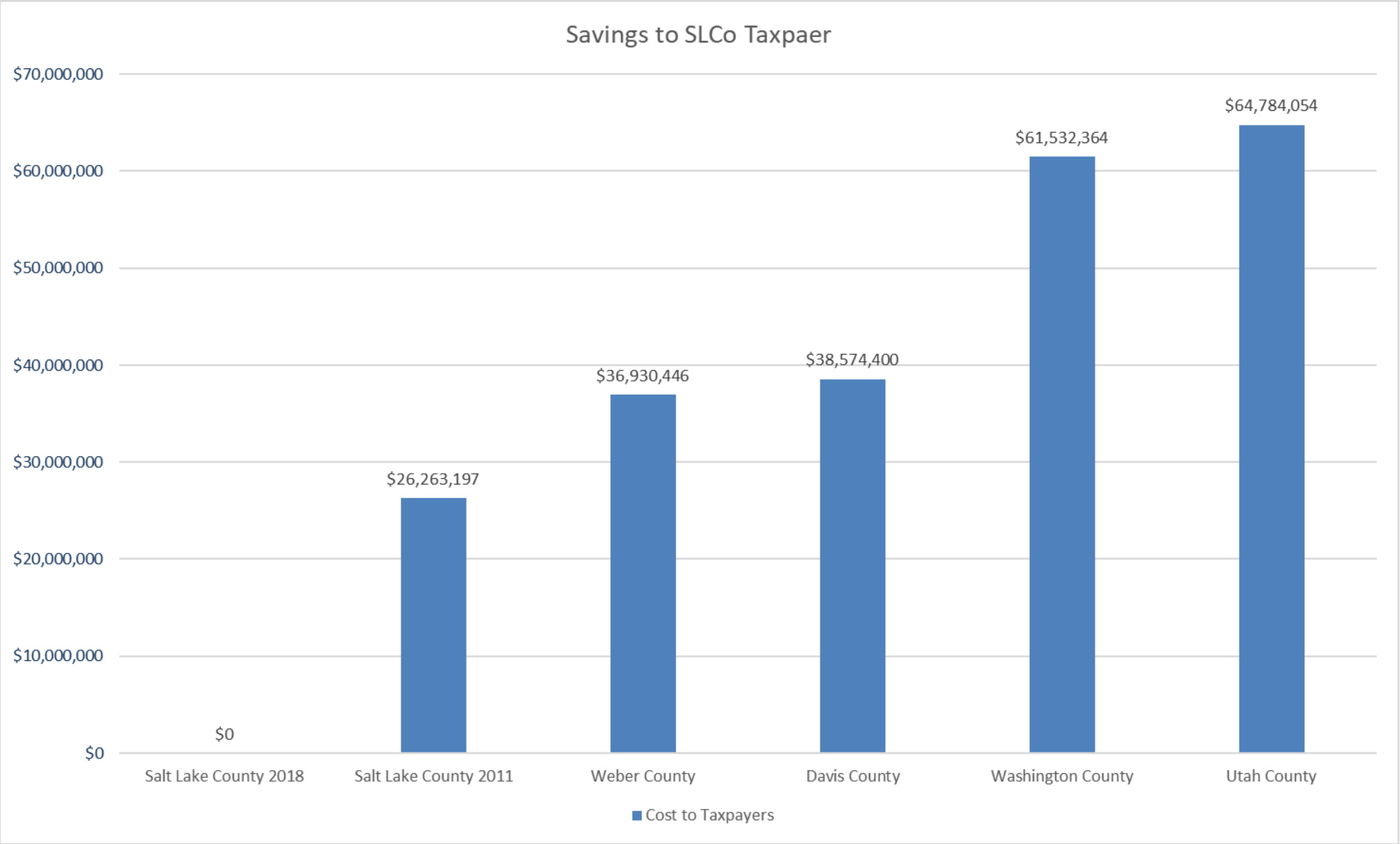
The percentage of taxpayers who are timely paying their taxes.

Taxes ↑ Delinquents ↓

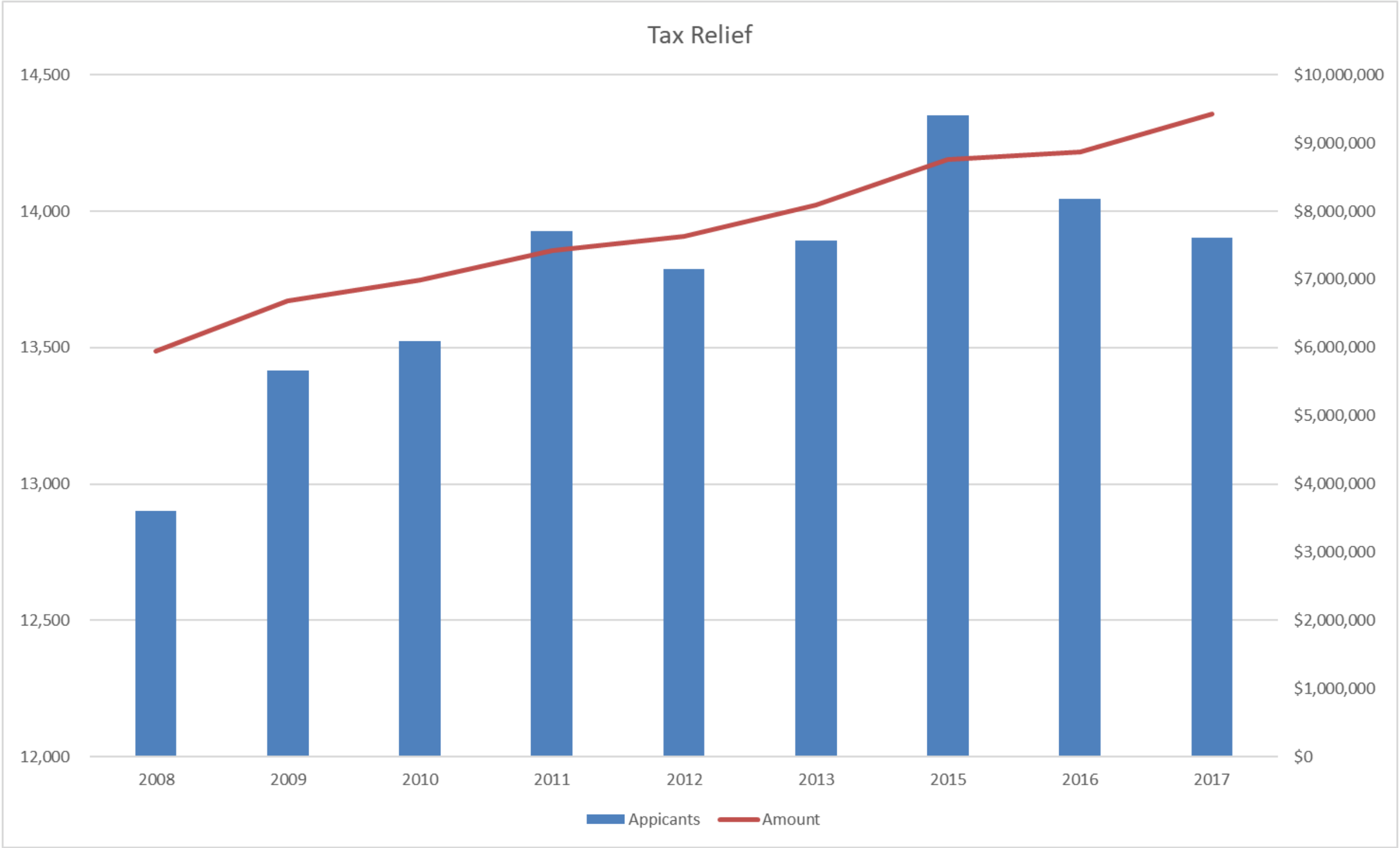
As property tax collection amounts increase, instead of delinquencies following that trend, delinquencies continue to decrease.

County Comparisons

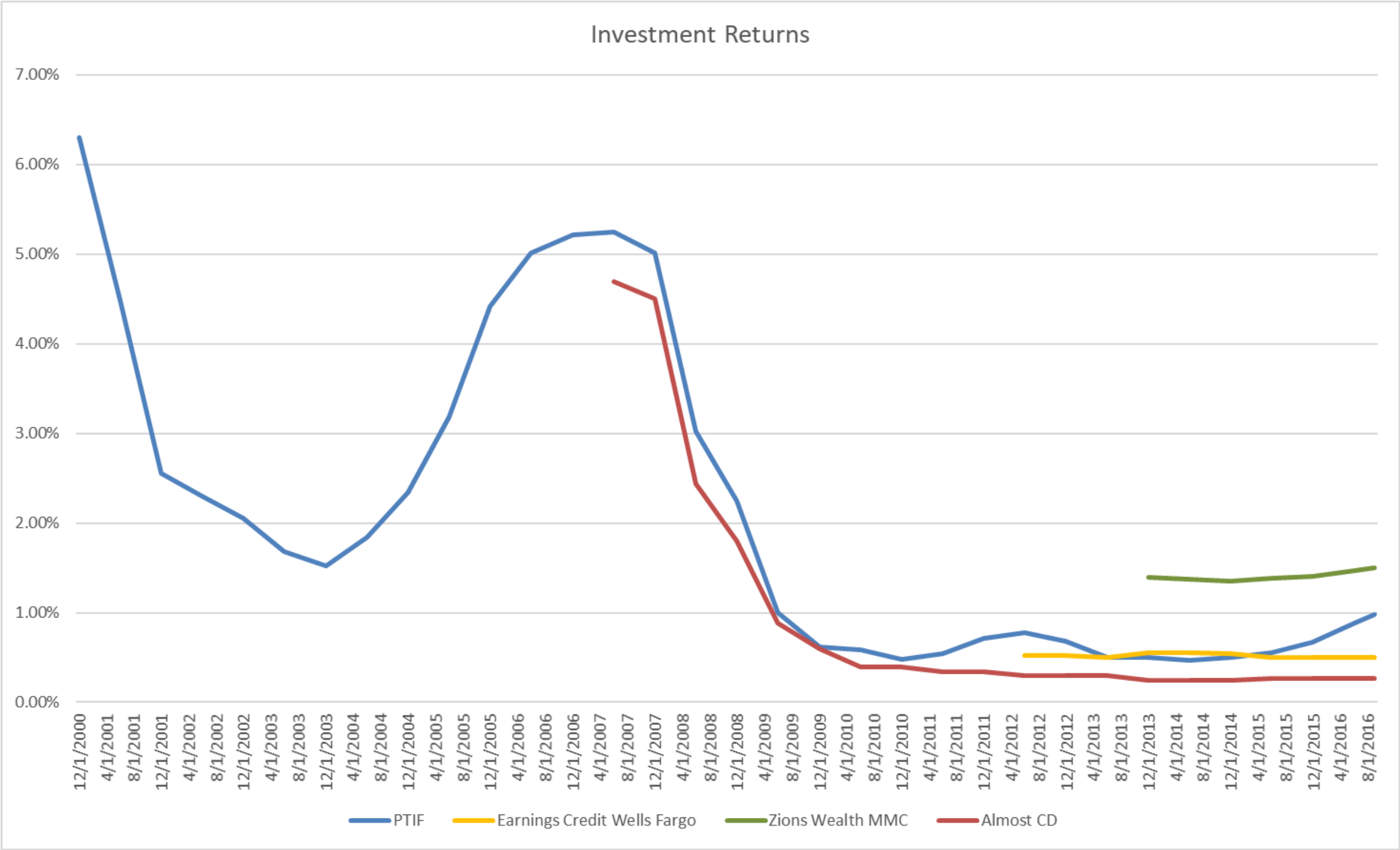
Due to excellent ongoing collection rates, SLCo residents pay less in property tax compared to other counties in Utah.

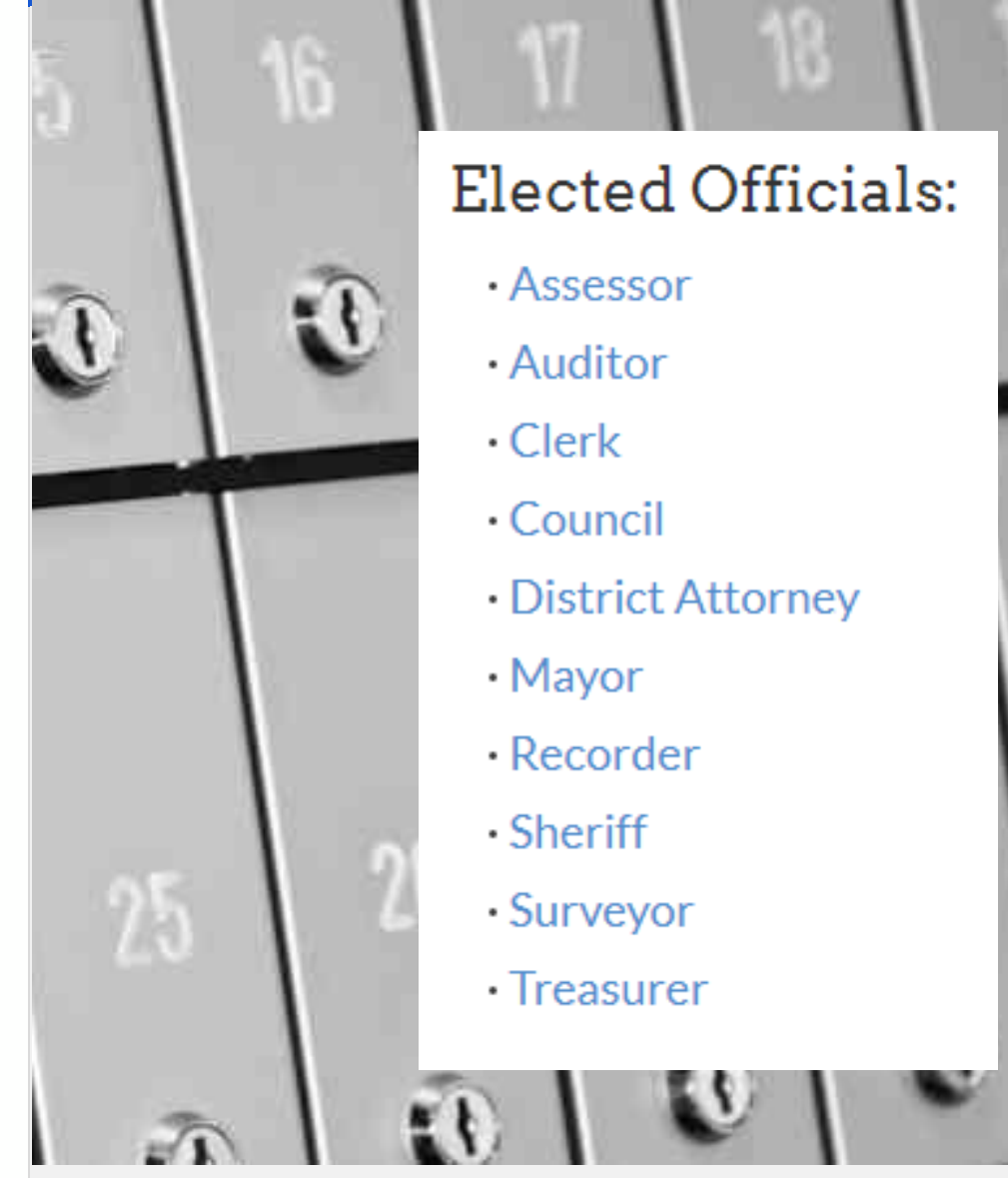

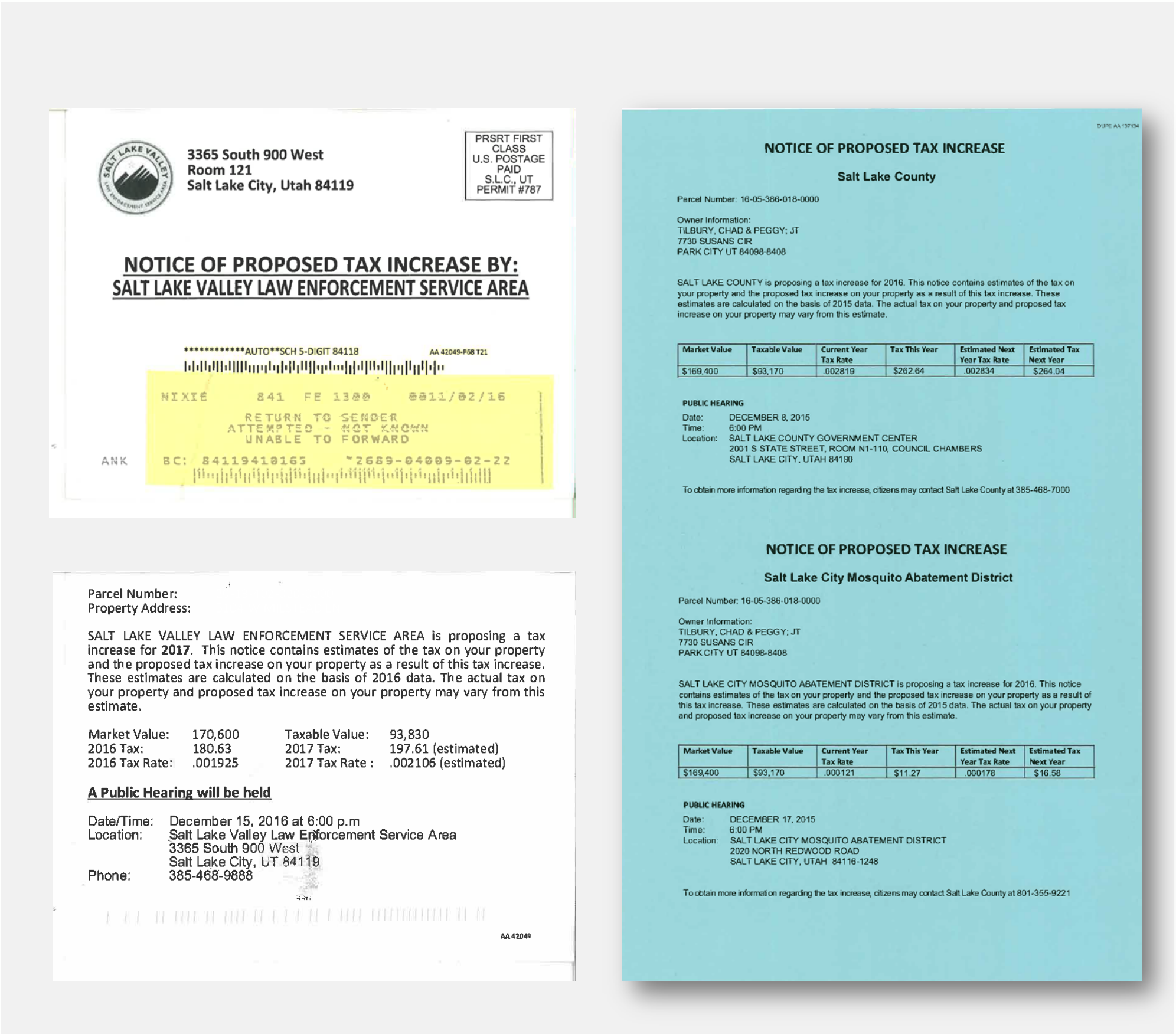
“NEW” ITEM #2 – PROPERTY TAX INCREASE ANNOUNCEMENT OPTIONS

POSTCARD

This approach is encouraged especially for last minute decisions to increase taxes. Treasurer coordinates and acts as a liaison between the taxing entity and the printer.

PROPERTY TAX NOTICE INSERT

Currently, with a legal size official Property Tax Notice we can add up to two entities that are raising property taxes. Parts of this form including font size, etc. is specifically outlined in statute.

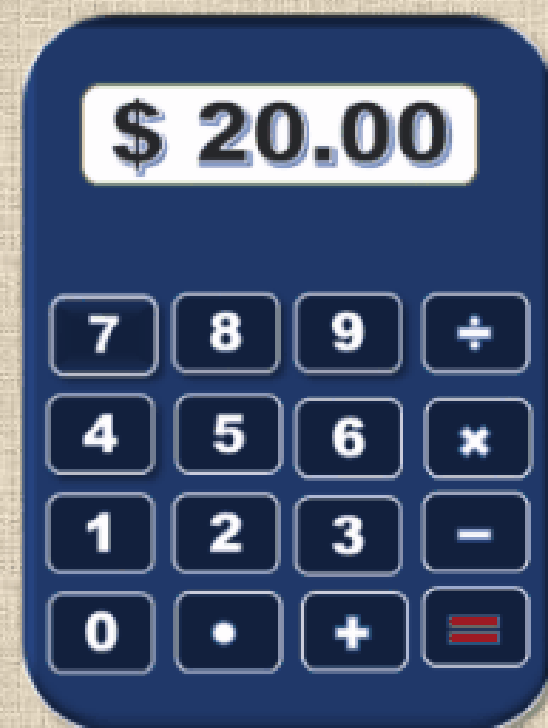
