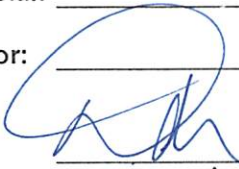

VOA Utah has partnered with Housing Assistance Management Enterprise to invest \$3.68 million to purchase and remodel an apartment complex on Denver Street in Salt Lake City. When completed, the complex will offer 22 apartments to the adults with severe and persistent mental illness, with on-site services provided by VOA's Assertive Community Treatment Team (ACT). The partnership was awarded, and successfully sold to Goldman Sachs, LIHTC credits. However, between the LIHTC application in 2017 and the contracting process in Spring 2018, construction costs increased from an estimated \$3.28 million to \$3.68 million. Because the project cannot sustain more debt, the partnership is seeking contribution to close the funding gap. \$400,000 is 11% of the development revenue

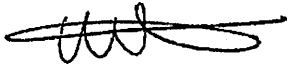
(f) To the best of our knowledge and belief, none of the new subordinates being added to the group exemption letter has obtained a separate ruling or determination letter relating to exemption.
