WHEREAS, the adoption of this resolution has been duly noticed in accordance with the Utah Open and Public Meetings Act, and Utah Code Ann. § 17B-1-609(1).

NOW, THEREFORE, the Governing Board of the Salt Lake County Municipal Building Authority, Utah, resolves as follows:

1. The MBA hereby adopts adjustments to the 2022 budget as set forth in Exhibit A.

2.	The MBA further declares that its budget provides for payment of debt, bond debt
service, if an	y, including transfers for appropriate fund balances, and that said debt service
payments exc	clude payments from any proceeds of Tax Anticipation Notes or borrowing,
consistent wi	th Treasury Department regulations.
