Dear Honorable County Council Chair DeBry:

The Zoo, Arts and Parks (ZAP) Tier II Advisory Board respectfully requests your consideration of their 2021 funding recommendations. During the 2021 application cycle, the ZAP Tier II program received 183 applications, with requests totaling over \$3.3 million dollars. Of these submissions, the Advisory Board is recommending 179 applicants for Tier II funding totaling \$2,427,150.

Earlier this year, the County Council approved an additional policy stating the ZAP Tier II Advisory Board would ensure a minimum of 5% of Tier II funding be distributed to each council district. The Board has met this threshold in all but one district. After much deliberation, the board determined meeting the 5% distribution policy would create inconsistencies in the evaluation process, give disparate treatment among districts, and set an unsustainable precedent. A letter from the Advisory Board Chair further explaining the reason for this recommendation has been included as part of this request. The letter also provides two additional funding scenarios for the Council's consideration. The funding for those scenarios are included in this packet.

The ZAP awards are based on a competitive process and organizations that apply are not guaranteed funding. Of the 183 submitted, four applications were determined to be ineligible for funding this year and have been encouraged to apply in future cycles.

If revenues do not meet projections and are less than the total recommended, each awardee (see detail attached) would be decreased a prorate amount. If the funding is more than the recommended amount, the excess funds will first be used for the Local Arts Agency Advancement initiative and then roll over for the 2022 Tier II process.

Thank you for your consideration of this request and for your continued support of the Zoo, Arts and Parks program.

Dear Honorable County Council Chair DeBry,

The ZAP Tier II Advisory Board is committed to a fair and thorough review process. Every year, the Board collectively spends hundreds of hours reviewing applications to ensure their funding recommendations reflect the established review criteria and support Tier II funding priorities. New this year, the Board has been asked by the Council to ensure a minimum of 5% of Tier II funding be distributed to each Council District. The Board understood the goal of this new policy and held multiple deliberations on how this threshold could be met. After much discussion, the board determined meeting the 5% distribution policy would create inconsistencies in the evaluation process, give disparate treatment among districts, and set an unsustainable precedent. The Board appreciates the opportunity to assess the funding distribution through this lens and agrees with the need to grow the arts in all Districts.

For this funding cycle, the Board has met the 5% funding minimum for all Council Districts with the exception of District 2. The Board's current recommendation of \$89,600 for distribution to District 2 equates to 3.69% of the approved budgeted recommendations for 2021. All nine applicants from District 2 have been recommended for funding including one first time applicant. After considerable deliberation, the Board approved to fund the Tier II applicants as presented through a majority vote.

While the Board took the new distribution policy under serious consideration, they ultimately determined it would require an extraordinary increase to a small number of applicants that would not be in line with previous funding recommendations and methodologies. Recommending 5% of Tier II funds to District 2 would dramatically inflate funding amounts for a small number of applications. No other District received similar treatment and it was important to the board that their approach remain consistent. The Advisory Board recognizes the intent of the policy and agrees that organizations from all Districts are worthy of funding but feel as though the artificial inflation of awards without merit would set an unsustainable precedent.

Even though the Board's current recommendation falls short of the 5% request by the County Council, ZAP anticipates an increase in applications from District 2 in future years. Part of this will be achieved through a new capacity building program ZAP is launching in the coming months. This program will provide tools to organizations in all districts to build capacity and improve the quality of submitted applications. Staff will also continue increased outreach efforts to identify new applicants from District 2 and all other Districts.

The Board would like to offer for your review the alternate scenarios that we considered in addressing the 5% gap in District 2. The first scenario shows District 2 recommendations as they are currently presented for approval. The second scenario shows increases in funding for all applicants from District 2 that the board views substantial but within the individual organizations' capacity. The third scenario shows how funds could be distributed to achieve the 5% distribution threshold but is not an option the Board fully supports based on the organizations' capacity and our evaluation criteria.
