AMENDMENT NO. 1

INTERLOCAL COOPERATION AGREEMENT FOR OAK HILLS TENNIS CENTER

This Amendment No.1 to the Interlocal Cooperation Agreement County Contract No. 0000001949 and City Contract No. 06-3-18-9910 (the "Agreement") is between Salt Lake County, a body corporate and politic of the State of Utah on behalf of its Division of Parks and Recreation ("County"), and Salt Lake City Corporation ("City"), a Utah municipal corporation. County and City are sometimes referred to as the "Parties."

WITNESSETH:

- A. County and City entered into an Interlocal Cooperation Agreement, Salt Lake County Contract
 No. 0000001949 ("the Agreement") whereby the County contributed the Recreation Bonds
 funds for City to complete the desired improvements to its Oak Hills Tennis Center facility.
- B. The Agreement requires the City to construct an improvement to real property thereby requiring approval of the County's legislative body pursuant to the Act.
- C. The Agreement will expire on July 17, 2021, but the work will not be complete for another 10 months.
- D. The City and the County wish to amend the Agreement to extend the termination date.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement:

- I. Section 6 of the Agreement is amended to read as follows:
 - 6. Term. This Agreement shall become effective upon execution and shall terminate May 17, 2022. Upon termination of this Agreement, the Parties shall be considered to have

- withdrawn from the joint or cooperative undertaking described in this Agreement.
- II. This Agreement will become effective as provided in the Utah Interlocal Cooperation Act, Utah Code Ann. § 11-13-209.
- III. All Parts, Paragraphs, Attachments and other provisions of the original Agreement that are not expressly modified by this Amendment No. 1 shall be the same and remain in full force and effect.
- IV. This Amendment No. 1 to the Agreement may be executed in two or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
