## SALT LAKE COUNTY ORDINANCE

JUNE 21, 2022

AN ORDINANCE, AMENDING TITLE 19, ENTITLED “ZONING” OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 2001, BY RECLASSIFYING CERTAIN PROPERTY LOCATED IN SALT LAKE COUNTY FROM THE A-20 ZONE (AGRICULTURE) TO THE M-2 ZONE (MANUFACTURING).

The Salt Lake County Council of Salt Lake County, State of Utah, ordains as follows:

Section 1: Section 19.06.020, Zoning Maps of Salt Lake County Code of Ordinances, 2001, is hereby amended as follows:

The property described in Application #REZ2022-000535 filed by Northrup Grumman and located at approximately 4400 South 9200 West within Salt Lake County, is hereby reclassified from the A-20 Zone (Agriculture) to M-2 Zone (Manufacturing), said property being described as follows:

PARCEL#: A portion of Parcel #'s 20-06-200-001-0000 and

20-06-100-001-0000 as follows:

LEGAL DESCRIPTION:

Land being a part of North Half of Section 6, Township 2 South, Range 2 West, Salt Lake Base and Meridian, U.S. Survey, in Salt Lake County, Utah:

Beginning at a point on the South line of said North Half, located 1425.27 feet North 89°55'56" East along the Quarter Section line from a point described of record as being a copper plug in a marked stone marking the West Quarter Corner of said Section 6; and running thence North 0°14'28" East 4048.00 foot radius curve to the right a distance of 139.71 feet (Center bears North 71°51'27" East 139.70 feet) to a point on a curve; thence Northeasterly (Center bears South 86°16'47" East, Central Angle equals 85°34'50" and Long 266.30 feet; thence North 77°05'57" East 684.02 feet; thence South Quarter Section Line; thence South 89°55'56" West 1767.33 feet along said Quarter Section Line to the point of beginning.

CONTAINS: 1,547,053 sq. ft.  
Or 35.515 acres

Section 2: The map showing such change shall be filed with the Salt Lake County Planning Commission in accordance with Section 16.06.020 of the Salt Lake County Code of Ordinances, 2001.

Section 3: This ordinance shall take effect fifteen (15) days after its passage and upon at least one publication in a newspaper published in and having general circulation in Salt Lake County, and if not so published within fifteen (15) days then it shall take effect immediately upon its first publication.

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL APPROVING THE FILING OF APPEALS BEFORE THE UTAH STATE TAX COMMISSION

IT IS HEREBY RESOLVED BY THE SALT LAKE COUNTY COUNCIL THAT:

WHEREAS, Utah Code § 59-2-1007(2) allows a county to object to an assessment and request a hearing with the Utah State Tax Commission under certain circumstances;

WHEREAS, PacifiCorp and Lumen have filed appeals for its 2022 assessments and other taxpayer-initiated appeals are expected; and

WHEREAS, it is in the County’s best interest that the County file appeals to protect the County’s financial interests and the equality of the tax burdens of taxpayers within its jurisdiction.

NOW, THEREFORE, the Salt Lake County Council resolves as follows:

1. That the District Attorney has authority to file cross-appeal responding to PacifiCorp’s and Lumen’s appeals.
2. That the District Attorney has authority to file protective appeals to any other appeal initiated by a taxpayer, and that the County be permitted to join its appeals with appeals of other counties; and
3. That the County Mayor direct the appeals under the advice of the District Attorney

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL REGARDING THE SALT LAKE COUNTY JUSTICE COURT

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL APPROVING AND PROVIDING NOTICE OF SALT LAKE COUNTY’S INTENT TO DISSOLVE ITS JUSTICE COURT AND TRANSFER ITS CASELOAD TO THE THIRD JUDICIAL DISTRICT COURT

BE IT KNOWN AND REMEMBERED:

THAT, the County Council of Salt Lake County, State of Utah, met in regular session of the Council on the 21st day of June, 2022.

WITNESSETH:

WHEREAS, the Legislature of the State of Utah has authorized at Utah Code Ann. § 78A-7-102(4)(c)(i) (2018 General Session, Senate Bill 79) that upon providing adequate notice of its intent to the Judicial Council and upon the Judicial Council’s certification that the expanded justice court complies with established operating standards, and may be dissolved and its jurisdiction transferred as provided in law; and

WHEREAS, to obtain approval of the Legislature to dissolve its justice court Utah Code Ann. § 78A-7-123 requires the governing authority of Salt Lake County to petition the Legislature to adopt a joint resolution to approve the dissolution and requires the County to provide notice to the Judicial Council no later than July 1 two years prior to the general session of the Legislature in which the County intends to seek legislative approval; and

WHEREAS, the Salt Lake County Council has determined that it is within the

best interest of the citizens of Salt Lake County to dissolve its county justice court; and

NOW, THEREFORE, BE IT RESOLVED,

THAT, the Salt Lake County Council hereby resolves that Salt Lake County shall notify the State of Utah, the Utah Judicial Council, and the Utah Administrative Office of the Courts by July 1, 2022, of Salt Lake County’s intent to dissolve its justice court in accordance with the terms of this resolution; and

THAT, Salt Lake County shall petition the Legislature during the 2025 General Session for a joint resolution to approve the dissolution of the Salt Lake County Justice Court as authorized under Utah Code Ann. § 78A-7-123.
