Dear Honorable County Council Chair Snelgrove:

The Zoo, Arts and Parks (ZAP) Tier II Advisory Board respectfully requests your consideration of their 2019 funding recommendations. During the 2019 application cycle, the ZAP Tier II program received 205 applications, with requests totaling over \$3.7 million dollars. Of these submissions, the Advisory Board is recommending **193** applicants for Tier II funding totaling **\$2,382,825**.

The ZAP awards are based on a competitive process and organizations that apply are not guaranteed funding. Of the 205 submitted, 12 applicants were not recommended for funding because the Tier II Advisory Board determined they did not meet the program requirements or were not considered to be competitive applications, given the increasing size of the applicant pool. Attached is the list of applications recommended for funding along with explanations for the declined applications.

If revenues do not meet projections and are less than the total recommended, each awardee (see detail attached) would be decreased a prorated amount. If the funding is more than the recommended amount, the excess funds will first be used for the Local Arts Agency Advancement initiative and then roll over for the 2020 Tier II process.

Thank you for your consideration of this request and for your continued support of the Zoo, Arts and Parks program.

2019 Tier II Applications Not Recommended for Funding (12):

1. Bluffdale Arts Advisory Board

This application exhibited an acute absence of detail, and in some cases lack of any response, for all application questions. Due to this, the Board finds it to be non-competitive and does not recommend this applicant for funding this year.

2. FutureINDesign

Due to the confluence of the extremely small audience size and single location, the Board finds this request to not exhibit high enough accessibility to allow it to be competitive within its applicant pool. The Board does not recommend this application for funding this year.

3. Love for Art

This applicant did not provide enough information to exhibit the organization's ability to maintain and build capacity, and the Board found that overall the explanations were too generalized to clearly assess the request. The Board does not recommend this applicant for funding this year.

4. Utah State Fair

This application is ineligible for funding as per Salt Lake Countywide Policy 1031: 3.16, in which the Festivals discipline disallows state fairs.

5. Wasatch Contrasts

Due to this organization's historical data and lack of differentiated funding sources, the Board does not find this applicant to exhibit enough organizational stability to be competitive for funding. The Board does not recommend this application for funding this year.

6. Big World Network (first-time applicant)

The Board does not recommend this organization for funding this cycle based upon the lack of detail within the application regarding the specific use of ZAP funds, and lack of other funding sources outside of ZAP to indicate organizational stability.

7. Common Good Press (first-time applicant)

This applicant did not provide enough information within their application regarding the project for which they were requesting funding to allow for full assessment. Due to this, the Board does not find this application to be competitive and does not recommend this applicant for funding this year.

8. Jung Society of Utah (first-time applicant)

The Board found that this applicant did not demonstrate strong enough evidence of the artistic and cultural merit of their request within the application (vs self help/psychology as a social science, disallowed in the Humanities discipline definition in Salt Lake Countywide Policy 1031: 3.16), and therefore does not recommend this applicant for funding this year.

9. Land Cruiser Heritage Museum (first-time applicant)

The Board does not find this application to be competitive due to a need for demonstrated organizational growth, and a clearer explanation of the museum's unique cultural narrative and outreach programming. The Board does not recommend this application for funding this year.

10. Sackerson Theatre (first-time applicant)

Due to large funding changes demonstrated within this organization's most recent fiscal years, the Board does not find this applicant to be competitive within its applicant pool and does not recommend this application for funding this year.

11. Umbrella Theatre Company (first-time applicant)

The Board did not find that this applicant demonstrated enough of a track record of the stability of the organization's unique concept to be competitive against other applications. The Board does not recommend this application for funding this year.

12. WE ARE ELEVN (first-time applicant)

Due to large funding changes demonstrated within this organization's fiscal data for future years, the Board does not find this applicant to be competitive within its applicant pool and does not recommend this application for funding this year.

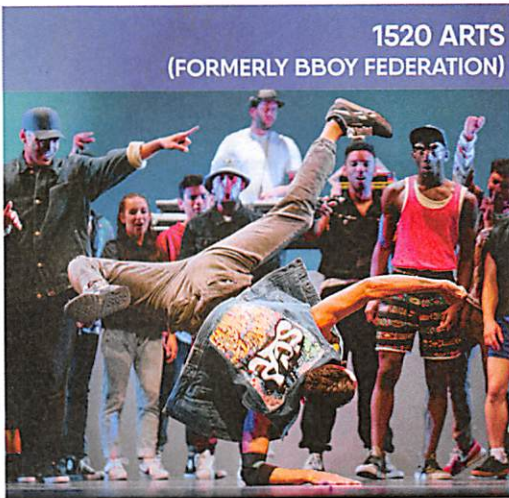
