It is further understood that no grant fund will be made available to any County officer of employee or in violation of the requirements of the Public Employees Ethics Act (67-16-1 et seq.). No grant funds will be used for political or campaign purposes. As a further condition of the grant, all County funds may be subject to an audit as required by Salt Lake County. The applicant is required to complete the Disbursement of Funds Report Form for contributions more than \$2,500.

This modifies our letter of the above date in which we stated that you would be treated as an organization which is not a private foundation until the expiration of your advance ruling period.


Based on the information you submitted, we have determined that you are not a private foundation within the meaning of section 509(a) of the Internal Revenue Code, because you are an organization of the type described in section 170(b)(1)(A)(vi). Your exempt status under section 501(c)(3) of the code is still in effect.

Grantors and contributors may rely on this determination until the Internal Revenue Service publishes notice to the contrary. However, a grantor or a contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act that resulted in your loss of section 509(a)(1) status, or acquired knowledge that the Internal Revenue Service had given notice that you would be removed from classification as a section 509(a)(1) organization.

Dear Applicant:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

Because you are a newly created organization, we are not now making a final determination of your foundation status under section 509(a) of the Code. However, we have determined that you can reasonably be expected to be a publicly supported organization described in section 509(a)(2)

Accordingly, you will be treated as a publicly supported organization, and not as a private foundation, during an advance ruling period. This advance ruling period begins on the date of your inception and ends on the date shown above.

Within 90 days after the end of your advance ruling period, you must submit to us information needed to determine whether you have met the requirements of the applicable support test during the advance ruling period. If you establish that you have been a publicly supported organization, you will be classified as a section 509(a)(1) or 509(a)(2) organization as long as you continue to meet the requirements of the applicable support test. If you do not meet the public support requirements during the advance ruling period, you will be classified as a private foundation for future periods. Also, if you are classified as a private foundation, you will be treated as a private foundation from the date of your inception for purposes of sections 507(d) and 4940.

Grantors and donors may rely on the determination that you are not a private foundation until 90 days after the end of your advance ruling period. If you submit the required information within the 90 days, grantors and donors may continue to rely on the advance determination until the Service makes a final determination of your foundation status. However, if notice that you will no longer be treated as a section 509(a)(2) organization is published in the Internal Revenue Bulletin, grantors and donors may not rely on this determination after the date of such publication. Also, a grantor or donor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act that resulted in your loss of section 509(a)(2) status, or acquired knowledge that the Internal Revenue Service had given notice that you would be removed from classification as a section 509(a)(2) organization.

The League of Women Voters was founded by Carrie Chapman Catt in 1920 during the convention of the National American Woman Suffrage Association. The convention was held just six months before the 19th amendment to the U.S. Constitution was ratified, giving women the right to vote after a 72-year struggle.

The League began as a “mighty political experiment” designed to help 20 million women carry out their new responsibilities as voters. It encouraged them to use their new power to participate in shaping public policy.

From the beginning, the League has been an activist, grassroots organization whose leaders believed that citizens should play a critical role in advocacy. The League is proud to be nonpartisan, neither supporting nor opposing candidates or political parties at any level of government, but always working on vital issues of concern to members and the public.

The League of Women Voters is organized and works on three levels: local, state and national. At each level, a volunteer president and board of directors govern the League. League members belong to all three levels of the League—local, state and national.

We are women and men of all ages and backgrounds working to increase the understanding of major public policy issues and to influence public policy through education and advocacy. We envision a democracy where every person has the desire, the right, the knowledge and the confidence to participate. We believe in the power of women to create a more perfect democracy. Our mission is to empower voters and defend democracy.

As a newcomer to Utah I knew I wanted to learn about local and state government and become involved in the community. The League is nonpartisan and does in-depth studies on topics I find important. We teach a high school class on the history & importance of voting that culminates in registering students to vote.

We attend ceremonies monthly to register new citizens and educate them about voting.

## UNIT MEETINGS

We facilitate small group discussion meetings to discuss our studies or to become educated on a current topic.

## FUN RUN & FESTIVAL

We held our first fun run in 2018. We plan on making it an annual event to encourage voter education & to get out the vote.



## THE LUNCHEON



The State of The Community Luncheon was first held in 1993, and since it has been the largest annual fundraising event for the League of Women Voters of Salt Lake. Ticket sales are open to the general public. Attendees of the luncheon include members of the League, our program partners, and community stakeholders.

### Christine Durham

Retired Chief Justice of the Utah State  
Supreme Court

Justice Durham was Utah's first female Supreme Court justice and helped to create the National Association of Women Judges and Women Lawyers of Utah. She was Chief Justice of the Utah Supreme Court from 2002 to 2012. She was appointed to the Utah Supreme Court by Gov. Scott M. Matheson in 1982 and retired in 2017.

In 2007 received the William H. Rehnquist Award for Judicial Excellence, one of the most prestigious judicial honors in the country.
