The Property Tax Committee, at a meeting on November 21, 2019, considered updating the Indigent/Hardship sliding scale for 2020. The Committee recommends the attached scale be approved for use in administering indigent and hardship relief for 2020. The scale uses the same income guidelines as the State Circuit Breaker program. Assets are added to income to determine the total resources available to a household. The actual amount of relief is determined after considering the total number of people in the household.
