2. CITIZEN PUBLIC INPUT

The following citizens spoke in opposition to health mandates, particularly mask mandates in schools, because the Board of Health is not made up of doctors, with the exception of one person, and Angela Dunn who has the authority to implement a health mandate is not a certified epidemiologist; the Covid virus is not isolated, so should have no bearing on a public system; masks have not been proven to be effective, and information about them keeps changing; the size of the Coronavirus particle passes through masks; masks have harmful effects - children are breathing in carbon dioxide, which causes headaches, sleepiness, loss of attention, nausea, bloody noses, and other health concerns; children cannot breathe wearing masks; children are being punished if they remove their mask to breathe; many children have anxiety wearing a mask; children who wear glasses cannot wear them with a mask; some children have medical exemptions and cannot wear masks; masks were not worn when children were dying from the flu; children have a greater chance of being run over by a car than getting Covid; decisions about children should be made by parents; and children should have the freedom to choose for themselves whether or not they want to wear a mask in a free country. There was also opposition to mandates in general, the vaccines, and the shutdowns because mandates are about control; people being forced to do things they are opposed to is much like what happened before the Holocaust; most people are not dying from Covid; research indicates SarsCoV-2 cannot be differentiated from the flu; many children have died from the flu; hospitals are not testing for the flu now; data is being selectively picked to create fear rather than all data being shown; mandating any medical treatment is unconstitutional and mind-blowing; people are being bribed with junk food, pop, and other things to get the Covid shot; there has been no talk about people improving their health and strengthening their immune system instead of getting the shot; natural immunity is being dismissed because there is no money to be made from it; the Centers for Disease Control (CDC) is not counting injection failure, a.k.a. breakthrough cases, unless someone is hospitalized or dies, which is obfuscating data; the CDC has too many false positives; lab work was not done with

the Pfizer protocol and is not being done when a patient has a heart attack; young and older adults are getting Pericarditis and Myocarditis from the vaccine, and to protect the children from these micro vascular complications from the vaccine, a study should be done to test the blood to see what the effects of the vaccine are; the vaccine is causing other major medical issues and killing people; people are being used as guinea pigs for the vaccine; the vaccination has not been approved by the Food and Drug Administration (FDA); the vaccine is not preventing people from getting Covid; and shutdowns have caused depression, anxiety and suicide.

The following citizens spoke in favor of a mask mandate in schools because masks have been scientifically proven to reduce the spread of Covid - they prevent moisture from leaving the mouth; a mask mandate can save lives; children cannot get vaccinated yet, so they can contract Covid at school if masks are not being worn, and they can spread it to people in their homes who could die or be unable to work, and spread it without even being aware they have it; the vaccine for children is so close to be approved, it would be unfair not to have the mask mandate until then to protect those not eligible for the vaccine; masks are the only defense children under 12 years old have against Covid; the CDC says all children should be wearing masks; other mandates are in place to keep people safe, such as seatbelts and car seats, so mask mandates should be in place too; without layers of protections, including masks and vaccines, there will have to be quarantines; without a mask mandate, some people will not wear a mask, thereby endangering all others; without a mask mandate, people wearing masks are fearful of being harassed while wearing a mask; masks allow for some return of normalcy regarding education and social life, and it is a child's right to attend school safely; children do not like wearing masks, but they do not like eating vegetables, brushing teeth, etc., so they will wear them so they can go back

to school and feel safe; masks give people a sense of comfort; masks do not impede learning, communication, or making friends; there are more risks from getting Covid than from wearing masks; anxiety and migraines from wearing masks are nothing compared to dying or having long-term effects from Covid; legislation banning the mask mandate eliminated the ability to navigate a public health crisis; masks have become political; people opposing masks are not experts in public health; and parents who do not want their child masked should keep them home. Others spoke about other concerns including Covid and vaccines stating medical professionals have the scientific understanding of Covid; Covid is real; people have lost their life to Covid; people have long-term effects from Covid; Covid cases continue to rise; children are getting sick and going to the hospital from Covid; the numbers of hospitalizations with the Delta variant has doubled at the same time hospitals are understaffed; the Council needs to consider the highly contagious variant and not allow experimentation on children, use the science presented instead of basing a decision on emotions, put difficult stories aside, and consider people of color; the Salt Lake County Health Department is pledged with promoting safety, including that of children, and people should listen to it; the thresholds put in place by the Legislature have been surpassed; it is grownups job to protect children, not sacrifice them; keeping freedom is giving up the safety of the whole; and vaccines can prevent people from dying.

Informational

Dr. Angela Dunn, Director, Salt Lake County Health Department, stated it was her goal to give the Council the best data, and health and science recommendations. The latest focus has been on school, and the goal is to have kids get in-person learning with as little disruption as possible. From a public health perspective, having students mask indoors will limit the spread of COVID-19 and decrease that disruption whether it is from kids actually getting COVID-19 and having to isolate or being exposed to it and having to quarantine.

She delivered a PowerPoint presentation on the COVID-19 weekly update reviewing the 7-day case rate that is 64 percent higher than last year; data showing 62 percent of Salt Lake County residents 12+ are fully vaccinated; cases of vaccinated and unvaccinated showing that without herd immunity or preventative measures, everyone's risk will increase with Delta; case rates and vaccination coverage by zip code; data showing that without preventative measures, severe illness will continue to increase; upcoming school vaccination clinics; and what is happening in other states.

Council Member DeBry asked how many children 12 and under were in intensive care units (ICU).

Mr. David Schuld, Intelligence Section Chief for COVID-19, stated three children ages 0-4 were currently hospitalized, as were four children ages 12-17, and 17 people ages 18-29 and 30-39. The highest group hospitalized now are 40-49-year-olds. Those are all Salt Lake County residents.

Mayor Wilson stated if another variant takes over, or if the County does not get back to declining cases, everyone could be at risk into the future. The County has to use every tool it has to stop the spread of Covid.

Discussion/Direction

Council Member Stringham reviewed the 2022 Unincorporated County Budget to be submitted to the Municipal Services District (MSD). She asked to pull out the \$41,600 earmark for the Central Wasatch Commission (CWC) because not enough Council Members were supportive of it, and the MSD did not know if that was something it had ever paid for before.

A motion was made by Council Member Stringham, seconded by Council Member Alvord, that this agenda item be approved and forwarded to the 4:00 PM Council meeting for ratification.

Ms. Catherine Kanter, Deputy Mayor of Regional Development, stated for at least two years, this account has been used to support the contribution to the CWC. The \$41,600 is also designated as an earmark in miscellaneous expenses. The Council is not bound to

spend that on the exact line items being earmarked.

Mayor Wilson stated a great deal of revenue generated by the ski resorts lands in the MSD budget, and the CWC's purpose is to be a convener of conversation around the canyon. The Council can kick the can down the road around the CWC about how much to fund it or if the County should fund it.

A motion was made by Council Member Stringham, seconded by Council Member Alvord, that this agenda item be approved, with the \$41,600 as a placeholder, but with removal of the earmark for the CWC, and that it be forwarded to the 4:00 PM Council meeting for ratification. The motion passed unanimously.

Council Member Snelgrove stated one of the best things the County can do to take pressure off the Wasatch Canyons is to make opportunities available in the Oquirrh Mountains. There are more than 20 camping and picnic sites in Millcreek, Big and Little Cottonwood Canyons, but zero in Butterfield, Yellow Fork, and Rose Canyons.

A motion was made by Council Member Snelgrove to approve legislative intent that the money freed up by the removal of the \$41,600 placeholder be committed to the study of picnic and camping sites in the Oquirrh Mountains.

Mr. Mitchell Park, Legal Counsel, Council Office, stated he did not know if that was an appropriate project for MSD funds or not. There are certain restrictions around the use of that money, so it would have to be looked into. The Council will have the ability to make decisions about the money it gets back from the MSD for the unincorporated residents at a later time.

Council Member Snelgrove withdrew the motion and directed legal counsel to look into this concept.

Ms. Megan Hillyard, Director, Administrative Services Department, stated this presentation is to showcase the new website redesign. She reviewed the history of the website redesign and the working committee. Negotiations are happening now to see how quickly this can be rolled out. Administrative Services wants to make sure it has enough of the traffic sites developed into templates before doing the launch.

Mr. Reid Demman, County Surveyor, stated he was elected by some of his fellow elected officials to represent them on this brainstorming committee. A lot of data and analytics was gathered, and the committee based its decisions on that data and what was most important for the constituents, as users.

Ms. Lisa Hartman, Associate Deputy Mayor, stated this is more than a redesign; it is a relaunch of how the County delivers services through its website and its calling card. A lot of people have positive touch points with the County, but then turn around and say they do not know what the County

does. The relaunch is a way to get the branding and connection for users to understand that.

Ms. Remy Fowles, Founder & Director, Niftic Agency, delivered a PowerPoint presentation on the Website Redesign, reviewing what the digital needed to be; the two phases of the project; the three themes that internal needs fell into; understanding user behavior, needs and pain points; user testing; a landscape analysis; the big picture goals and considerations on how to accomplish the goals; content inventory; information architecture; wireframing; high-fidelity components and key pages; navigation to introduce a simple and service-focused structure; wireframing for creating simplified templates and modular systems; wireframing to introduce cohesive and consistent elements; search and discovery; service-first aggregator pages; the pilot programs; the identified areas for content consolidation and more efficient user flows to reach page content efficiently; identified areas for page flow improvements and progressive disclosure; application of the library of cards, templates, and modular systems; build out of each page with updated content, actions, resources; collaborate optimization and finalization of page content; color palette and accessibility contrast; and typography and legibility.
