**Mayor Jennifer Wilson** stated two Salt Lake County agencies were recently honored by the National Association of Counties - Adult & Aging Services was recognized for their program that supports older refugees and Animal Services was recognized for its free microchipping program.

**Ms. Charise Jensen**, Program Manager, Adult & Aging Services Division, stated the program focusing on older adult refugees is to prevent social isolation. A grant from the Refugee Services Office allows them to do such things as teach sewing classes in English, create gardens, and get refugees involved in senior centers. This has made a huge impact on the lives of these refugees.

**Ms. Michelle Jones**, Animal Control Officer, Animal Services Division, stated Animal Services offers free microchips for pets in the community. She and Officer Don Belnap have expanded that service to include microchipping done in the field. Chipping is a guaranteed ticket home for a dog or cat. It also keeps animals out of the shelter, relieving stress on staff and animals.

RESOLUTION NO. 5612

A RESOLUTION OF THE COUNTY COUNCIL OF SALT LAKE COUNTY, UTAH, PROVIDING FOR SEPARATION PAY TO EMPLOYEES OF PLANNING AND DEVELOPMENT SERVICES WHO WILL BE SUBJECT TO A REDUCTION IN FORCE.

BE IT KNOWN AND REMEMBERED:

THAT, the County Council of Salt Lake County, State of Utah, met in regular session of the Council on July 30th, 2019.

RECITALS

1. Pursuant to agreement between the Greater Salt Lake Municipal Services District (“MSD”) and Salt Lake County (“County”), the County has determined that certain employees of the County’s Planning and Development Services Division (“PDS Employees”) shall be separated from County employment on a future date (“Separation Date”). The MSD and the County currently contemplate that the Separation Date shall occur on or about September 30, 2019.
2. In recognition of the service of PDS Employees and the unique circumstances of the separations, the County Council has determined that it would be appropriate and in the public interest to provide separation pay to each Qualified PDS Employee (as hereinafter defined) in the form of a one-time payment as set out herein. For purposes hereof, the term “Qualifying PDS Employee” shall mean any PDS Employee who is

employed by the County on the date that the Reduction notice is delivered by the County to such Qualifying PDS Employee and who does not exercise his/her “bumping” rights under Salt Lake County Human Resources Policy 2-900.

- 3. The Council finds that providing separation pay to the Qualifying PDS Employees is permitted under Salt Lake County Human Resources Policy 2-900 (II)(O).

RESOLUTION

- 1. Qualifying PDS Employees shall be eligible for separation pay described herein.
- 2. A separation payment for eligible Qualifying PDS Employees shall be equal to one and a half week’s pay for the employee at their rate of pay on the separation date, multiplied by every 5 years of the eligible employee’s service, calculated from the employee’s applicable merit date to the Separation Date.

RESOLUTION NO. 5613

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL  
AUTHORIZING EXECUTION OF THREE EASEMENTS FOR THE  
BENEFIT OF THE CITY OF SOUTH JORDAN

WITNESSETH

- A. The Salt Lake County Council authorized a Boundary Line Agreement with the City of South Jordan (the “City”) pursuant to Resolution 5456 adopted on December 11, 2018.
- B. As part of the Boundary Line Agreement, Salt Lake County (the “County”) adjusted the boundaries of Parcel No. 27-15-351-001 (“Parcel 001”) and Parcel No. 27-15-351-002 (“Parcel 002”) which are both owned by the County and located at approximately 11059 South 2200 West, South Jordan, Utah 84095.
- C. The City has an underground storm drain line that passes under Parcel 001 and an underground water line that passes under Parcel 001 and 002. These underground storm drain and water lines pre-existed the Boundary Line Agreement between the City and the County.
- D. In order to recognize the existence of the storm drain line and the water line on the property now owned by the County, the County and the City have prepared a Storm Drain Easement and two Waterline Easements.
- E. Because these documents formally recognize a pre-existing condition and are related to the Boundary Line Agreement already approved by the County Council, it is proposed to authorize these easements for no fee.
- F. It has been determined that the best interests of the County and the general public will be served by entering into the Storm Drain Easement attached hereto as Exhibit A and the two Waterline Easements attached hereto as Exhibits B and C. This action will comply with all applicable state statutes and City and County ordinances.

RESOLUTION

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the Storm Drain Easement and the two Waterline

WHEREAS, the Legislature of the State of Utah has provided one hundred thousand dollars (\$100,000) to Salt Lake County to expand naturalization efforts in Salt Lake, Davis, Utah, and Weber counties;

WHEREAS, the benefits of naturalization include higher earning potential for new citizens, additional tax revenue, increased voting and political participation, and improved connection between communities;

WHEREAS, the Legislature of the State of Utah has provided at Utah Code 11-13-202.5 for the adoption of interlocal agreements, pursuant to a resolution of the governing body of any political entity which is a party to such an agreement;

WHEREAS, Salt Lake County and the City of Ogden have determined, through their governing bodies, that it would be in the best interest of the contracting governmental entities, and the inhabitants thereof, to enter into an interlocal agreement whereby Salt Lake County will provide twenty thousand dollars (\$20,000) to the City of Ogden to expand naturalization efforts in Weber County;

WHEREAS, providing twenty thousand dollars (\$20,000) to the City of Ogden will aid in fulfilling the purposes for which Salt Lake County received the funds from the Legislature of the State of Utah;

WHEREAS, such an interlocal agreement has been prepared, is attached hereto, and is agreeable to the parties;

WHEREAS, City has the need of prisoner transportation services to and from its Justice Court; and

WHEREAS, Sheriff’s Office provides prisoner transportation services to various courts within Salt Lake County;

WHEREAS, Sheriff’s Office is willing and able to adequately provide prisoner transportation services for the Justice Court; and

WHEREAS, the City has determined that it is in its best interest to enter into an agreement within the County under the Act, whereby Sheriff’s Office provides prisoner transportation services to City under the terms and conditions as set forth in the Agreement, attached hereto as Exhibit 1;

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL DECLARING SURPLUS REAL PROPERTY AND APPROVING THE CONVEYANCE OF THE SAME BY QUIT-CLAIM DEED TO ROSALIE J. KILHOLM

RECITALS

1. Salt Lake County (the “County”) owns a parcel of real property, Parcel No. 22-17-202-001, located at approximately 1002 East Revere Cir., Murray, Utah (the “Property”), which was struck off to the County after the tax sale in 1982.
2. Rosalie J. Kiholm owns a parcel of land adjacent to the Property (the “Buyer”).
3. Buyer has offered to purchase from the County the Property for its appraised value of \$2,700, which has been reviewed and approved by the County Real Estate Division, and has paid a fee of \$100, which amount shall be credited towards the purchase prices of the Parcel. This offer is in the form of a Tax Sale Property Purchase Agreement (the “Agreement”) attached hereto as Exhibit A.
4. The County has determined that the Parcel is not currently in public use and that the Property has an appraised value of \$2,700. Proceeds from the sale of the Parcel will be distributed in accordance with Section 59-2-1351.5 of the Utah Code.
5. The best interest of the County and the general public will be served by the sale and conveyance of the Parcel to Buyer for its fair market value. The



sale and conveyance will be in compliance with all applicable state statutes and county ordinances.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the Parcel described in Exhibit 1 of the Agreement is hereby declared surplus property.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the sale and conveyance of the Parcel by quit-claim deed to Buyer as provided in the Agreement for the agreed appraised value of Two Thousand Seven Hundred dollars (\$2,700) is hereby approved; and the Mayor is hereby authorized to execute the Agreement and the Mayor and County Clerk are authorized to execute the Quit-Claim Deed, attached to the Agreement as Exhibit 2, and to deliver the fully executed documents to the Salt Lake County Real Estate Division for delivery to Buyer in accordance with the terms of the Agreement.
