Discussion/Direction

**Ms. Kersten Swinyard**, Director, Economic Development Division, Office of Regional Development, stated the amendment would adjust the terms of the participation agreement between the Salt Lake County Redevelopment

Agency and MWIC Magna, LLC. The amendment is required by Senate Bill 250, which passed during the most recent legislative session. This bill requires a participation agreement to have a provision authorizing an agency to use funding that would otherwise be provided to a participant under the participation agreement to pay a participant's delinquent property tax or privilege tax or resolve a political subdivision lien against the participant.

## RESOLUTION NO. 151

RESOLUTION OF THE GOVERNING BOARD OF THE REDEVELOPMENT AGENCY OF SALT LAKE COUNTY APPROVING AN AMENDMENT TO THE PARTICIPATION AGREEMENT WITH MWIC MAGNA, LLC

#### RECITALS

WHEREAS, the Redevelopment Agency of Salt Lake County (the "RDA") adopted the Magna/Arbor Park Project Area Urban Renewal Plan on June 16, 2009;

WHEREAS, on January 18, 2023, the RDA entered into a participation agreement with MWIC Magna, LLC, to use a portion of its tax increment to assist MWIC Magna, LLC in the development of its property located within the project area;

WHEREAS, during the 2025 General Session, the Utah State Legislature enacted Senate Bill 250, which requires participation agreements between community reinvestment agencies and developers to include a provision authorizing the agency to use funding that would otherwise be provided to the developer to pay the developer's delinquent property tax or privilege tax or resolve a political subdivision lien against the developer (see Utah Code § 17C-1-202(5)(d) (2025));

AND WHEREAS, Amendment No. 1 to the Participation Agreement, attached hereto as Attachment "A," amends the participation agreement to include the new requirement.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Governing Board of the Redevelopment Agency of Salt Lake County that Amendment No. 1 to the Participation Agreement is approved.
