RESOLUTION NO. 6258

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL GRANTING A FINAL APPROVAL FOR THE ACQUISITION OF A PARCEL OF REAL PROPERTY LOCATED IN SALT LAKE COUNTY AND THE EXECUTION OF CLOSING DOCUMENTS

RECITALS

- A. On September 10, 2024, the Salt Lake County Council (the “Council”) authorized the execution of an Agreement for Purchase and Sale of Real Property and Escrow Instructions for the purchase of certain real property located in Salt Lake County (the “Property”) by approving Resolution 6232.
- B. Following the issuance of Resolution 6232, the Agreement for Purchase and Sale of Real Property and Escrow Instructions was signed by the Salt Lake County Mayor on September 16, 2024, and was subsequently amended to extend the Inspection Period and the Closing Date (collectively the “Agreement”).
- C. Under the terms of the Agreement, Salt Lake County (the “County”) has been conducting due diligence, including various inspections and evaluations (the “Inspections”), during Inspection Period (the “Inspection Period”).
- D. Pursuant to Section 4.3 of the Agreement, the Council must give a final approval for the purchase of the Property prior to the end of the Inspection Period.
- E. Having conducted the Inspections, the Council now is prepared to give its final approval for the acquisition of the Property before the Inspection Period expires.
- F. It has been determined that the best interests of the County and the general public will be served by giving this final approval for the acquisition of the Property pursuant to the terms of the signed Agreement.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake

County Council to give its final approval for the acquisition of the Property pursuant to the terms of the Agreement for the agreed upon sum of fifty-two million dollars (\$52,000,000).

IT IS FURTHER RESOLVED by the Salt Lake County Council that the Mayor is hereby authorized to execute such other documents as may be reasonably necessary to purchase the property and effectuate the closing contemplated by the Agreement.
