Can we please get the attached 3 budget adjustments processed. They are:

4510000IA01 – Adding \$1,000,000 to the Engineering budget for a project on 2550 S between 7200 W and 8000 W. The funds are going from UDOT to the MSD and the MSD is contracting with the County to pass the funds to Engineering. The MSD should be approving a budget adjustment today to recognize the funds at their level.

450000IA01 – Adding 2 new Engineer FTEs..This is a request made by the Greater Salt Lake Municipal Services District during their 2019 budget adoption. With the amount of outstanding projects, Public Works Engineering cannot manage nor complete the projects efficiently. These additional 2 FTEs will allow Public Works Engineering to complete more projects and spend down the carry forward amount of approximately \$15MM.

405000IA01 – Transferring an FTE from Outreach to Planning. This is a filled position that will be transferred to Planning and Development to perform essentially the same functions. Currently there are 2 FTEs in Outreach. 1 FTE is retiring in January and the Greater Salt Lake Municipal Services District decided to not continue funding for that position. With the dwindling of the budget in Outreach it made more sense to transfer the FTE and funding to Planning. As part of the June budget adjustment we will try to close 1015 Community Outreach and Engagement.
