- SB 246 Urban Farming Assessment Act Amendments

Ms. Kara Trevino, Intergovernmental Relations Manager, Council Office, stated this bill lowers

the acreage requirement to qualify for urban farming from two acres to one acre and allows urban farming to include “other marketable crops.”

Mr. Kevin Jacobs, County Assessor, stated this would be a tax shift with no loss of revenue to the County. Approximately 3,000 additional parcels within Salt Lake County could qualify for this program.

Council Member Bradley stated changing the bill to include “other marketable crops” is not realistic. It should be limited to consumable food.

Council Member Bradshaw stated the Council agreed to this bill in concept, but the lobbyist team should be directed to work with the sponsor to more narrowly define "other marketable crops."

- SB 240 Property Tax Exemption for Wildfire Prevention

Ms. Trevino stated this bill is dead. There was not enough time to get it passed. The bill would have provided for a property tax exemption for wildfire prevention efforts on certain properties.

- SB 263 Property Tax Definition Amendment

Ms. Trevino stated this bill amends the definition of educational purposes as it relates to property tax exemption. Educational purposes means the same as the 501(c)(3) term used in the Internal Revenue Code.

- HB 93 5th Substitute County Formation Amendments

Ms. Trevino stated this bill would have removed a requirement requiring a majority vote in the remaining part of an existing county to create a new county. It failed in the House with a vote of 29 in favor and 40 in opposition.

- HB 44 Tax Equalization and Reduction Act

Ms. Trevino stated this bill is dead for now.

- SB 129 2nd Substitute Retirement Safety and Firefighter Tier II Retirement Enhancements

Ms. Trevino stated the Legislature is trying to figure out funding for the \$3.5 million fiscal note that is attached to this bill. The bill is currently in the House Rules Committee.

- SB 162 Corrections Officer Certification Amendments

Ms. Trevino stated this bill passed.

- HB 200 3rd Substitute Appointment of Constables Amendments

Ms. Trevino stated on March 5, 2019, the Council instructed the lobbyist team to work with the sponsor of this bill to change some language. The changes were successfully made.

- SB 187 County Planning and Services Amendments

Ms. Trevino stated this bill passed out of the Senate and is now in the House. There was an amendment to the bill, which changed the sunset date from 2023 to 2021.

- SB 77 Tax Increment Amendments 1st Substitute

Ms. Trevino stated the language was successfully changed on this bill to hold the County and school districts harmless.

- HB 431 Expungement Act Amendments

Council Member Burdick stated this bill has moved out of committee.

Mr. Trevino stated the fiscal note attached to the bill has been lowered from \$4 million to \$1.8 million.
