

**Mission:** Dedicated to providing affordable and accessible housing options for all residents and support for broad community service providers.




#### **Outcomes:**

- SLCo residents have safe and energy efficient homes.





### Successes

- Secured \$5.1M in new Lead Abatement Grant funds through 2027
- Awarded \$300,000 for a Solar for All Pilot Program
- \$4.7M going out for new affordable housing development in 2024
- \$25M allocated for affordable housing, resulting in 1545 new units
- Completed division reorganization, securing new leadership, and undergoing a strategic plan

## Regional Planning & Transportation

**Mission:** Dedicated to creating sustainable and thriving communities through comprehensive regional plans, transportation strategies, and land use management.



#### **Outcomes:**

- SLCo works collaboratively with state and local partners to create and execute regional development plans that align with SLCo policy priorities.
- SLCo and partners invest in a robust, multimodal transportation network to enhance residents' quality of life and visitors' experience.
- SLCo influences local planning actions to align with national best practices and regional goals.
- All SLCo Planning Commission and Mountainous Planning Commission positions are filled, and members are representative of the communities they serve.



## **Regional Context**

- Salt Lake County's population will grow by 35% from 2024 to 2060
- We support the linkage between land use and transportation to reduce congestion/travel time as well as enhance air quality
- Public engagement in regional transportation plans and projects allows people to express how they want to get around Salt Lake County
- Legislature is a key partner in setting transportation funding and direction



## Stakeholder Engagement

- Regional Solutions highlights topics of county wide importance with keynote speaker and subject matter expert panels
- We recruit and train members for the Salt Lake County Planning Commission and the Mountainous Planning Commission
- Surveys and open houses are often used to gather information to inform projects and policies. (Example: Federal Lands Access Program Upper Mill Creek Canyon Road Improvement Project)
- Quarterly Transportation Funding Workgroup meetings to identify funding for projects for local jurisdictions transportation projects.

- Corridor preservation for future roadway and public transit in collaboration with local jurisdictions and COG Public Works Committee
- Update of parking ordinance in Little and Big Cottonwood Canyon

#### **Outcomes:**


- SLCo safeguards and preserves our natural resources to foster thriving and resilient communities.







